The town welcomes the newly appointed Plummer Cemetery Sexton as the former Sexton retired. After almost 40 dedicated years, Bill Behringer decided to retire. He recommended Elizabeth “Beth” Binns (Plummer), keeping the name and traditions in the family. Beth was born a Plummer, her family members are buried at the cemetery, and she has a background having worked in the funeral business, making her what will be a great caretaker and steward of Plummer Cemetery.

Bill Behringer was appointed on May 13, 1985 as Sexton of the cemetery, followed by his father, Jake Behringer, who was Sexton for twelve years prior. The Town of Oshkosh honors Bill’s devotion to keeping this historical marker alive.

Stormwater Management

Have you ever watched water run down a gutter or pool on the side of the road during a storm? What happens to all the water? Most stormwater—the water from rain and snow—runs over the land and down a storm drain. The water flows through a network of underground pipes and open channels directly to our streams, rivers, and lakes. That's why keeping stormwater clean is vital to the health of our waterways, community, and even our economy.

KNOW WHAT'S IN THE FLOW

When water flows off our property after a storm, what's on our lawns, roads, buildings, and parking lots flows with it. The water that doesn't soak into the ground picks up oil, litter, fertilizer, and other unhealthy items along its way that wind up in our rivers, lakes, and streams.

Water pollution can start on your property in ways you cannot see, but that affect your health and the whole community downstream. Watching what we put in our storm drains and



on our property makes our rivers, lakes, and streams cleaner, healthier, and more enjoyable. And by investing in solutions to manage stormwater, we help make our community a safer, greener, healthier, and more enjoyable place to live.

Jerry was born January 19, 1942 and passed away on January 9, 2025.

He served the Town of Oshkosh for a total of 36-years. His long-term civic dedication included:

Elected Town Supervisor from April 1981 to April 1991 (10-years)

Elected Town Chair from April 1991 to April 2011 (20-years)

Elected Town Supervisor from April 2011 to April 2017 (6-years)

Other Reminders...

- ⇒ CONCRETE is NEVER allowed in the road right-of-way/ driveway approaches.
- ⇒ Permit is required for new installation and replacements of a driveway culvert.
- ⇒ Disposal of unused items like rubbish, or yard waste in town ditches and road right-of-way is prohibited. Violators may be fined and charged for removal costs.
- ⇒ Permit is required for any disturbance of road right-of-way/ ditches.

Home/building address numbers MUST be clearly marked and visible from the road. Our first responders want to find your location quickly if there is a *medical emergency*.

The Town of Oshkosh Uniform Numbering System ordinance Title 6, Chapter 5, regulates standards, mandates compliance, and specifies enforcement.

As required under the Wisconsin State Statutes, owners of dogs in the Town of Oshkosh must have rabies vaccination and be licensed.

Vaccination against rabies of all dogs by a veterinarian is required within 30-days after the dog reaches 5-months of age and revaccinated within one-year after the initial vaccination. If the owner obtains the dog or brings the dog into this state after the dog has reached 5-months of age, the owner shall have the dog vaccinated against rabies within 30-days after the dog is obtained or brought into the state unless the dog has been vaccinated or evidenced by a current certificate of rabies vaccination from this state or another state. Older vaccinated dogs must be revaccinated before the certificate expires within three-years of the previous vaccination. Certificates of current vaccination by a veterinarian must be presented when obtaining dog licenses.

The license fee for neutered males or spayed females is \$3.00, upon presentation of evidence that the dog has been neutered or spayed, and \$8.00 for not neutered male or not spayed female dogs.

Dogs that become 5-months of age after July 1st will be assessed at 50% of the regular license fee.

New residents of the town have 30-days to obtain a dog license.

Penalties

A late fee of \$5.00 shall be added to the owner of each dog 5-months of age or who fails to obtain and renew his or her dog license after April 1st or after required deadline. An owner who fails to meet the dog licensing requirement by statute may be required to forfeit no less than \$50.00 nor more than \$100.00.

Illicit Discharge, what is it?

An illicit discharge is any discharge into the Town's stormwater drainage system (i.e. roadside ditches) that is not composed entirely of storm water or uncontaminated groundwater. Such discharges are considered "illicit" because the storm sewer system is not designed to accept, process, or discharge such non-stormwater wastes or contaminants. Illicit discharges include dumping of motor vehicle fluids, household hazardous waste, paint, grass clipping, leaf litter or animal waste. The illicit discharge may be a deliberate discharge, or runoff from a contaminated site. It must be stopped in order to ensure that our stormwater discharges do not pollute the waters of the State. To prevent water pollution from threatening our waters, the Town of Oshkosh passed an [illicit discharge ordinance](#) (Title 8;Chapter 7). Any discharge of a potentially polluting substance directly or through underground pipes that reaches the Town stormwater drainage system is against this ordinance. This ordinance prohibits illicit discharges and aims to prevent and eliminate illegal discharges. The ordinance also gives the Town of Oshkosh enforcement authority.

Examples of potential water pollution or illicit discharges:

- Cleaning paint containers or brushes outside.
- Grease or other substances leaking from a dumpster.
- Oil, chemical spills.
- Concrete washout water draining from a construction site.

These things are preventable and all of us should do our part in not letting these pollutants make it into our lakes.
