

ORDINANCE NO. 2A
Addition to Ordinance 2

An Ordinance Relating to Animals Running at Large and Barking Dogs

The Village Board of the Village of Marquette, Green Lake County, Wisconsin, duly assembled at its regular meeting on 13th day of September, 1999, does ordain as follows:

SECTION ONE: ANIMALS RUNNING AT LARGE

1. No person having in his/her possession or ownership any animal or fowl shall allow the same to run at large within the Village. The owner of any animal, whether licensed or unlicensed, shall keep his/her animal tied or enclosed in a proper enclosure so as not to allow said animal to interfere with the passing public or neighbors. Any animal running at large unlicensed and required by state law or Village Ordinance to be licensed shall be seized and impounded by a humane or law enforcement officer.

2. A dog or cat shall not be considered to be running at large if it is on a leash and under control of a person physically able to control it.

SECTION TWO: BARKING DOGS

It shall be unlawful for any person knowingly to keep or harbor any dog which habitually barks, howls or yelps to the great discomfort of the peace and quiet of the neighborhood or in such manner as to materially disturb or annoy persons in the neighborhood who are of ordinary sensibilities.

SECTION THREE: PENALTY

Any person who violates either, Section One or Two of this Ordinance shall be subject to a forfeiture of not less than Twenty-five Dollars (\$25.00) and not more than One Hundred Dollars (\$100.00) plus costs for the first violation and not less than Fifty Dollars (\$50.00) and not more than Two Hundred Dollars (\$200.00) plus Costs for subsequent violations.

SECTION FOUR:

This ordinance shall be in full force and effect upon passage and publication.

AMENDMENT TO ORDINANCE NO. 2, VILLAGE OF MARQUETTE,
GREEN LAKE COUNTY, WISCONSIN
(Dog Ordinance)

WHEREAS, The Village of Marquette has a dog ordinance which is known as Ordinance No. 2 for the Village of Marquette.

WHEREAS, the Village Board has received complaints about dogs running loose, and

WHEREAS, the Village Board feels that the dogs shall be kept under control for twelve months of the year.

THEREFORE, the Village Board, Village of Marquette, Green Lake County, Wisconsin, do ordain as follows:

All persons, corporations or keepers of dogs shall keep their dog, or dogs, as the case may be, that they own or have under their control, locked up, penned or on a durable leash from January 1st to December 31st of each and every calendar year.

This amendment to Ordinance No. 2 shall be in effect after said hearing and passage and posting in three public places within the Village of Marquette.

VILLAGE ORDINANCE REGULATING DOGS IN THE VILLAGE
OF MARQUETTE.

An ordinance regulating and providing for penalties for the Violation of its Provisions regarding dogs.

Be it ordained by the Village Board of the Village of Marquette Green Lake County, Wisconsin.

Definition: For the purpose of this Ordinance the term "Dog" Shall mean any breed of dog whether a mongrel or pedigreed.

All persons shall keep their dogs or the dogs they have control of locked up, penned, or on a durable leash from March 15th to November 15th of each and every calendar year.

The President of the Village of Marquette shall annually on or before March 15th cause to be posted in at least 3 conspicuous places in his municipality or published at least once each week for 2 consecutive weeks in one or more newspapers having general circulation in the Village of Marquette, a notice that every person is required to keep his dog penned, chained, locked up or on a leash during said period.

The Village Marshall or any deputy sheriff shall take care of said duties in regard to locking up of dogs.

ANY PERSON, FIRM, OR CORPORATION violating any of the provisions of this Ordinance, shall be guilty of a misdemeanor, punishable by a fine of not less than \$10.00 nor more than \$50.00 and each violation shall constitute a separate offense.

If any Section, paragraph, clause, or sentence of this Ordinance shall be held invalid by a Court of competent jurisdiction, such holding shall not affect the remaining Sections, paragraphs, clauses, and sentences.

AMENDMENT TO ORDINANCE NUMBER 2A

The Village Board of the Village of Marquette in session duly begun on the 11th day of October, 2021, does ordain as follows:

Section One: Ordinance No. 2A, Section Three: Penalty, shall be amended to read as follows:

SECTION THREE: PENALTY

Any person who violates either Section One or Two of this Ordinance shall be subject to a forfeiture as follows:

1. First forfeiture: \$25 to \$200 plus court costs.
2. Second forfeiture: \$50 to \$300 plus court costs.
3. Third forfeiture: \$100 to \$400 plus court costs.
4. Fourth forfeiture: \$200 to \$500 plus court costs.
5. Fifth or subsequent forfeiture: \$400 to \$600 plus court costs, and the court may order the dog forfeited to a law enforcement or Animal Control Officer for impoundment.

Section Two: This ordinance shall take effect from and after its passage and publication as required by law.
