

ORDINANCE NO. 47

AN ORDINANCE CREATING A PLAN COMMISSION FOR THE PURPOSE OF
PREPARING A COMPREHENSIVE PLAN PURSUANT TO
SECTION 66.1001 OF THE WISCONSIN STATUTES

WHEREAS, the Village of Marquette desires to commence the necessary proceedings to complete a comprehensive plan pursuant to Section 66.1001 of the Wisconsin Statutes.

WHEREAS, part of the process for the comprehensive plan involves the Plan Commission or another body of local government recommending the adoption of a comprehensive plan by adopting a resolution by a majority of the entire commission or governmental unit.

WHEREAS, in the Village of Marquette there does not exist a Plan Commission to do such work.

WHEREAS, in order to prepare and complete the comprehensive plan, it is necessary for the Village to create a Plan Commission.

NOW, THEREFORE, the Village Board of the Village of Marquette, of Green Lake County, Wisconsin, DOES ORDAIN AS FOLLOWS:

SECTION ONE: Pursuant to Section 61.35 of the Wisconsin Statutes, a Plan Commission is created to adopt a comprehensive plan as described in Section 66.1001 of the Wisconsin Statutes.

SECTION TWO: As provided in Section 61.35 of the Wisconsin Statutes, the powers as set forth in Section 62.23 of the Wisconsin Statutes would apply to the Plan Commission to accomplish the preparation of said comprehensive plan.

SECTION THREE: The Plan Commission shall consist of the President of the Village who shall be the chairman, one Trustee of the Village Board and five citizen members. The five citizen members and one Trustee shall be appointed by the Village President, subject to confirmation by the Board. Each member's term shall be until the Plan Commission has done its work pursuant to Section 66.1001 of the Wisconsin Statutes and said comprehensive plan has been finalized and adopted. Vacancies shall be filled by appointment for the remainder of the unexpired term in the same manner as appointment for the full term.

SECTION FOUR: The Village Board shall appropriate funds for the Plan Commission to carry out its duties. The Plan Commission shall have authority to expend, under regular procedures, all sums appropriated to it for the purposes and activities authorized herein.

SECTION FIVE: The Plan Commission shall organize by the election of a vice-chairman, secretary and such other officers as may in its judgment be necessary. The Plan Commission shall keep written record of the proceedings to include all action taken, a copy of which shall be filed with the Village Clerk. Four members shall constitute a quorum but all actions shall require the affirmative approval of a majority of all of the members of the Plan Commission.

SECTION SIX: Once the Plan Commission has done its work as described herein, said commission shall then be disbanded and the powers of the Plan Commission shall be null and void. The Village President shall determine when said Plan Commission shall be disbanded.

SECTION SEVEN: Effective Date. This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
