RESOLUTION NO. 2021-2

PART OF A PUBLIC SQUARE AND AN UNPAVED ALLEY IN BLOCK 19 IN THE VILLAGE OF MARQUETTE

The Village Board of the Village of Marquette, in session duly begun on this 20th day of September, 2021, does resolve as follows:

WHEREAS, The Village Board of the Village of Marquette introduced a Resolution on August 9, 2021, proposing to vacate and discontinue part of a Public Square and an unpaved alley in Block 19 located in the Village of Marquette. The legal description of that part of a public square and the part of an unpaved alley proposed to be discontinued and vacated is as follows:

Being an alley and part of Second Street Public Square, all in Block 19, Map of Marquette, located in the Southwest Quarter of the Southwest Quarter, Section 25, Town 15 North, Range 11 East, Village of Marquette, Green Lake County, Wisconsin, described as follows:

Commencing at the Southwest Quarter corner of said Section 25; thence North 00°03'28" West along the West line of the Southwest Quarter, 336.81 feet; thence North 89°33'51" East along the South line of a 12 foot wide alley and its Westerly extension thereof, 97.28 feet to a point in the Easterly right-of-way line of County Trunk Highway H and being the point of beginning; thence North 09°07'40" East along said Easterly right-of-way line of County Trunk Highway H, 12.17 feet to a point in the South line of Lot 50, Block 19; thence North 89°33'51" East along the South line of Lot 50 and the North line of a 12 foot wide alley, 117.02 feet to the Southeast corner of Lot 50; thence North 00°51'08" West along the West line of a 12 foot wide alley and the East line of Lots 50, 49, 48, 167.04 feet to the Northeast corner of Lot 48; thence South 89°30'57" West along the North line of Lot 48, 25.06 feet to a point in the Southeasterly right-of-way line of County Trunk Highway H; thence Northeasterly along a 243.06 foot radius curve to the right in the Southeast right-of-way line of County Trunk Highway H having a central angle of 10°26'10" and whose long chord bears North 56°06'00" East, 44.21 feet to a point in the West line of Lot 33; thence South 00°51'08" East along the West line of Lots 33, 32, 31 and 30 and being the East line of a 12 foot wide alley, 203.40 feet to the Southwest corner of Lot 30 and the Northeast corner of Lot 26; thence South 89°33'51" West along the North line of Lots 26, 25 and 24 and being the South line of a 12 foot wide alley, 131.13 feet to the point of beginning. Containing 4,046 square feet (0.09 acres), more or less.

A map showing that part a public square and an unpaved alley being proposed to be discontinued is attached hereto as Exhibit A and is the highlighted portion of said map.

WHEREAS, on August 9, 2021, a hearing was held on the Petition and no one objected to the proposed Petition, and

WHEREAS, prior to said hearing on August 9, 2021, all interested persons were served with the Notice of Hearing, said Notice was published in the legal paper as a Class 3 Notice and at least 40 days have elapsed since the Petition was introduced by the Village Board.

NOW THEREFORE, BE IT RESOLVED, by the Village Board of the Village of Marquette, Green Lake County, Wisconsin that the following part of a Public Square and an unpaved alley located in Block 19 is vacated and discontinued and no longer a public square and alley and that this resolution shall be recorded in the Register of Deeds Office, Green Lake County, Wisconsin. The legal description of that part of a public square and an unpaved alley vacated is described as follows:

Being an alley and part of Second Street Public Square, all in Block 19, Map of Marquette, located in the Southwest Quarter of the Southwest Quarter, Section 25, Town 15 North, Range 11 East, Village of Marquette, Green Lake County, Wisconsin, described as follows:

Commencing at the Southwest Quarter corner of said Section 25; thence North 00°03'28" West along the West line of the Southwest Quarter, 336.81 feet; thence North 89°33'51" East along the South line of a 12 foot wide alley and its Westerly extension thereof, 97.28 feet to a point in the Easterly right-of-way line of County Trunk Highway H and being the point of beginning; thence North 09°07'40" East along said Easterly right-of-way line of County Trunk Highway H, 12.17 feet to a point in the South line of Lot 50, Block 19; thence North 89°33'51" East along the South line of Lot 50 and the North line of a 12 foot wide alley, 117.02 feet to the Southeast corner of Lot 50; thence North 00°51'08" West along the West line of a 12 foot wide alley and the East line of Lots 50, 49, 48, 167.04 feet to the Northeast corner of Lot 48; thence South 89°30'57" West along the North line of Lot 48, 25.06 feet to a point in the Southeasterly right-of-way line of County Trunk Highway H; thence Northeasterly along a 243.06 foot radius curve to the right in the Southeast right-of-way line of County Trunk Highway H having a central angle of 10°26'10" and whose long chord bears North 56°06'00" East, 44.21 feet to a point in the West line of Lot 33; thence South 00°51'08" East along the West line of Lots 33, 32, 31 and 30 and being the East line of a 12 foot wide alley, 203.40 feet to the Southwest corner of Lot 30 and the Northeast corner of Lot 26; thence South 89°33'51" West along the North line of Lots 26, 25 and 24 and being the South line of a 12 foot wide alley, 131.13 feet to the point of beginning. Containing 4,046 square feet (0.09 acres), more or less.

A map showing that part of a public square and an unpaved alley being proposed to be discontinued is attached hereto as Exhibit A and is the highlighted portion of said map.
