Part 4. Fee schedule.

Class I = \$50

Class II = \$100 up to 10,000 sq ft of floor area plus \$50 for each additional 1,000 sq ft of floor area

Class III = \$250 up to 10,000 sq ft of floor area plus \$50 for each additional 1,000 sq ft of floor area

Class IV = \$500

Additional charge:

Any culvert pipe installed by the Highway Department of the Town shall require an additional charge to the flat fee of \$5 per foot of pipe, with a minimum of a 20 feet length of pipe. Pipe lengths greater than 20 feet must be in 10 feet increments.

Part 5. Standards.

- The design and construction of any driveway shall conform to the same standards and/or guidelines that have been adopted by the Yates County Highway Department.
- A driveway shall be located entirely within the owner's frontage and have a minimum setback distance of 5 feet from an adjoining lot's property line.
- One driveway shall be permitted per lot of record unless approved otherwise by the Highway Superintendent of the Town.
- All driveways shall be constructed to slope away from the edge of the Town highway at the same slope as the shoulder.

Part 6. Attestation by the Applicant.
