

RESOLUTION NO. 2025-11**RESOLUTION FOR PARKING RESTRICTIONS**

WHEREAS, the Town of Ixonia Town Board adopted an ordinance to allow changes to parking restrictions in the Town of Ixonia by resolution;

WHEREAS, per the Ixonia Code of Ordinances, the following streets have No Parking restrictions; and

NOW THEREFORE, the Town Board hereby resolves:

Section 1: The Town of Ixonia, hereby upholds and enforces Parking Prohibited in certain specified places. No person shall stop or leave any vehicle standing in any of the following places except temporarily for the purpose of loading or unloading passengers while the vehicle is attended by a licensed operator so that it may promptly be moved in case of an emergency or to avoid obstruction of traffic:

- a. In a loading zone
- b. In an alley in a business district
- c. Within 10' of a fire hydrant, unless a greater distance is indicated by an official traffic sign
- d. Within 4' of the entrance to an alley or a private road or driveway
- e. Closer than 15' to the near limits of a crosswalk
- f. Upon any portion of a highway where and at the time when parking is prohibited, limited or restricted by official traffic signs
- g. Overnight parking is prohibited on any roadway for more than 2 hours, between the hours of 2 am and 6 am on any day

Section 2: The Town of Ixonia hereby upholds and enforces No Parking in certain specified Places. No person shall stop or leave standing any vehicle, whether attended or unattended and whether temporarily or otherwise, in any of the following places:

- a. Within an intersection
- b. On a crosswalk
- c. On a sidewalk or sidewalk area, except when parking in such places clearly indicated by official traffic signs, markers or parking meters.
- d. On the roadway side of any parked vehicle unless double parking is clearly indicated by official traffic signs or markers
- e. On the left side of the street or highway
- f. Audobon Park
 - i. Audobon Park Drive – north or west side
 - ii. Snowyowl Lane – south side
 - iii. Cardinal Pass – east side
 - iv. Whippoorwill Road – east side
- g. Autumn Ridge
 - i. Woody to Hwy P going south to Hwy F
 - ii. Right side of road from Hwy P to Tamarack
- h. Lewis Lane
 - i. From County Hwy F to Marietta Avenue both sides of road

- i. Madison Avenue
 - i. Northside from Wisconsin Avenue to Ski Slide Road
- j. Marietta Avenue
 - i. From CTH F to River Valley Road and on River Valley Road to STH 16
 - ii. From Hwy F o Cardiff/Swansea north side of street
 - iii. From Park Street to Hwy F – south side of street
- k. North Street
 - i. East side from Marietta Avenue north 84' from centerline of Marietta
 - ii. West side from Marietta Avenue to STH 16
- l. Preserve at Deer Creek
 - i. Fieldcress Court – south side and within radius of cul-de-sac
 - ii. Winterberry Lane – south side
 - iii. Deer Creek Circle
 - iv. Meadowsweet Pass – north side & within cul-de-sac
 - v. Winding Ridge Trail – west side
 - vi. Winding Ridge Court – within radius of cul-de-sac
 - vii. Waterlily Drive – south side
- m. River Valley Estates
 - i. Hunter Lane – River Valley to Marietta – north and east side
- n. River Valley Road
 - i. South of Marietta is designated “Fire Lane” on west side of road
- o. Vicksburg
 - i. Vicksburg Way – both sides of street
 - ii. Maple Ridge – both sides of street
 - iii. Thompson Circle – both sides of street
- p. Hustisford Road
 - i. From River Road to Majesta Court – both sides of road
- q. River Road
 - i. East of Hustisford Road to the dead end
- r. Overland Road
 - i. From River Road to cul-de-sac on east side of road

WHEREAS the Town Board added the additional roads to the No Parking for safety in the area near the Jefferson County Interurban Trail effective January 14, 2025; including,

- s. Rockvale Road
 - i. 1,800 feet east and west of the Interurban Trail
- t. Ski Slide Road
 - i. From Rockvale Road to 1,800 feet south of the Interurban Trail

Section 3: SEVERABILITY

The several sections of this resolution are declared to be severable. IF any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The

remainder of the resolution shall remain in full force and effect. Any other resolution whose terms are in conflict with the provisions of this resolution are hereby repealed as to those terms that conflict.

Section 4: EFFECTIVE DATE

This resolution shall take effect immediately upon passage and posting or publication as provided by law.
