Posted Seasonal Weight Limits

This is to serve as notice that spring seasonal weight limits for the Town of Bristol roads are now in effect. During the spring thaw season, no vehicles in excess of 10-tons will be allowed on Town Roads without permission of the Town. The duration of this restriction will be dependent upon the weather but will likely last until mid-April. You can acquire a permit by printing the application from our website www.tn.bristol.wi.gov and submitting the completed permit with a \$30 permit fee to the Town of Bristol office. If you choose to mail the application in, please submit a stamped envelope for return of your permit. Permits are issued on a as needed basis.

Please also remember that permits are required at all times for vehicles in excess of 10 tons traveling on Town of Bristol roads. Policy Statement: Permits for Exceeding Posted Road Weight Limits

Per Town of Bristol Ordinance 2015-2, permits are required for vehicles traveling Town roads in excess of the posted 10 ton limit.

Annual permits are required:

- 1. For all vehicles not covered under WI Act 377 (IOH) that will use town roads and exceed the posted 10 ton limit, and
- 2. That travel town roads either once or twice daily or intermittently (such as delivery trucks that have customers in Bristol i.e., UPS or Milk Trucks).

Permits are required for each job!:

- 1. For companies whose vehicles are not covered under WI Act 377 (IOH) and exceed the posted 10 ton limit, and
- 2. That will make multiple or repeated trips on town roads over a specified period of time (such as gravel or cement trucks making repeated trips to a job site or manure haulers making multiple trips for a specific farm operation).

Fees:

1. Permits for Excessive Weight issued by the Town of Bristol as described above, are subject to a \$25 administrative fee.

Damages to Roads:

Permits are issued on the condition that the permit holder assumes complete responsibility for all damages resulting from the trips made by their vehicle(s).
