Tax payments should NOT be combined with any other fee payment. Please include your PHONE NUMBER on your check.

If paying with an escrow check, make sure to endorse the back.

TO RECEIVE A PAID RECEIPT, PLEASE ENCLOSE A STAMPED, SELF-ADDRESSED ENVELOPE.

### Payment Options:

- **Payment can be mailed to:** Town of Bristol Treasurer, 7747 County Road N, Sun Prairie, WI 53590
- **Town Hall Drop Box:** Located to the left of the front door & is checked several times a day during tax time.
- **Paying In Person:** You may do so at the Town Hall during open business hours. Normal hours apply (Monday – Thursday 9:15 a.m. to 4:30 p.m.) unless stated below.

- **Tax Payment by Credit Card or E-Check:** The Town of Bristol has tax payment processing on our *website*. Go to [www.tn.bristol.wi.gov](http://www.tn.bristol.wi.gov), hover over "How Do I?" and select "Pay Property Taxes Online", fill in the information and submit. Payments are credited the day they are made.

Be aware that a convenience fee is charged when using this service.

You can **NOT** include your dog license & recycling fees on the same check. They must be separate. We only accept check or cash. Recycling permits and dog licenses can be purchased during the December & January extended office hours.

### DOG LICENSES MUST BE PURCHASED BY MARCH 31, 2024

\$20.00 each for neutered/spayed dogs. \$25.00 for un-neutered/spayed dogs. Kennel licenses are \$55 (up to 12 Dogs). For each dog to be licensed, you must provide proof of current rabies vaccination, and complete one of the application forms included.
