2025 PROPERTY TAXES ARE DUE BY JANUARY 31, 2026

Make check payable to: Town of Bristol

Tax payments should NOT be combined with any other fee payment.

Please remember to have sufficient funds in your account and including your phone number on your check helps us reach you if there are issues. Double check your written amount your check as that is what the bank will go by.

If paying with an escrow check, make sure to endorse the back.

Payment Options:

- **Payment can be mailed to:** Town of Bristol Treasurer, 7747 County Road N, Sun Prairie, WI 53590
- **Town Hall Drop Box:** Located to the left of the front door & is checked several times a day during tax time.
- **Paying In Person:** At the Bristol Town Hall during open business hours.
Normal hours apply (Monday – Thursday 9:15 a.m. to 4:30 p.m.) unless stated below.

- **Tax Payment by Credit Card:** Town of Bristol has tax payment processing on our *website*. Go to www.tn.bristol.wi.gov, click on "How Do I?" and select "Property Tax Payment", fill in the information and submit. Payments are credited on the day they are made.

Be aware that a convenience fee is charged when using credit card service.

You can NOT include your dog license & recycling fees on the same check. They must be separate checks.

Recycling permits and dog licenses can be purchased during December & January extended office hours.
