# TOWN OF JACKSONPORT ORDINANCE NUMBER 02-2008 SNOWMOBILE ORDINANCE

This ordinance revises and replaces the "Snowmobile Route Ordinance" Dated January 25, 1978

The Town Board of the Town of Jacksonport, Door County, Wisconsin do ordain as follows:

#### Section I - Intent

The intent of this ordinance is to provide a means for persons to travel with snowmobiles on certain Town roads of Jacksonport, Door County, Wisconsin for short distances to allow snowmobile operators to connect to snowmobile routes.

## **Section II - Statutory Authority**

This section of the ordinance is adopted as authorized under s.350.18 of the Wisconsin Statutes.

#### Section III - Designated Roadways and/or Highways

No person shall operate a snowmobile on a roadway or shoulder of a highway not designated as a snowmobile route other than the following:

- 1.) Sunny Slope Road from County T to Kiehnau Road 1 mile.
- 2.) N. Junction Road from County A to Elm Drive 1 mile.
- 3.) Honold Road from Elm Drive to town line just west of Hibbards Creek .5 mile.
- 4.) Pit Lane from N. Junction to end of Pit Lane .25 mile.
- 5.) Jorns Road from County V to State Highway 57 1.2 mile.
- 6.) N. Cave Point Drive from State Highway 57 to Clark Lake Court 1.81 mile.
- 7.) Schauer Road to town line .78 mile.
- 8.) North and South Clark Lake Drive from Clark Lake Court .86 miles.
- 9.) Clark Lake Court .78 miles.

### Section IV - Speed

A snowmobile operated on a portion of the roadway or shoulder of a highway pursuant to this ordinance shall observe roadway speed limits and travel in single file on the extreme right side of the roadway and travel with the flow of traffic. Lights should be on at all times. Snowmobile operators shall yield to the right-of-way to other vehicle traffic and pedestrians.

### Section V - Enforcement

This ordinance shall be enforced by any law enforcement officer of The County of Door, Wisconsin.

#### **Section VI - Penalties**

Wisconsin State snowmobile penalties as found in s.350.11 (1) (2) Wis. Stats., are adopted by reference.

### Section VII - Severability

The provisions of this ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the reminder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.

### Section VIII - Effective Date

This ordinance will become effective upon passage and publication as provided by law. Adopted by the Town Board this 22 day of January, 2008.
