ORDINANCE NO. 1-91

AN ORDINANCE TO ESTABLISH THE ANNUAL OPERATING BUDGET FOR  
CALENDAR YEAR 1991

BE IT ORDAINED BY THE TOWN COUNCIL OF THE INCORPORATED TOWN  
OF GILBERT, ARKANSAS:

SECTION 1. The annual budget for calendar year \_\_\_\_\_ is hereby  
identified as "Town of Gilbert BUDGET for \_\_\_\_\_" adopted by reference. A copy of said Budget shall be filed in  
the Office of the Town Recorder/Treasurer and shall be available  
for inspection by any person during normal office hours.

SECTION 2. EXPENDITURE CATEGORIES. Expenditure of funds  
appropriated by this Ordinance shall be restricted to the  
line item amounts under each major category.

SECTION 3. TRANSFERS. Any transfer of moneys between the  
General Fund, Street Fund or the major categories under these  
funds shall be made only with prior approval of the Gilbert  
Town Council.

SECTION 4. If any provision or section of this Ordinance is  
held invalid by a court of competent jurisdiction, such  
invalidity shall not effect other provisions of this Ordinance.

SECTION 5. This Ordinance being necessary for the protection and  
preservation of public health and safety, an emergency is  
hereby declared to exist and this Ordinance shall be in force  
and take effect upon passage and publication.
