

RESOLUTION NO. 742

A RESOLUTION TRANSFERRING EXCESS
PROPERTY TO DISTRICT ENTITIES OF
GOVERNMENT

WHEREAS, The Northwest Arkansas Economic Development District, Inc. has been obtaining personal excess property for the District entities of government, and

WHEREAS, Public Law 94-519 now authorizes the Economic Development Administration (EDA) to transfer this property to the District, and

WHEREAS, Public Law 94-519 further authorizes the District, by resolution, to pass titles of property to the local entities of government.

NOW, THEREFORE, BE IT RESOLVED BY THE NORTHWEST ARKANSAS ECONOMIC DEVELOPMENT DISTRICT, INC. THAT:

1. The Entity of Government covered under this Resolution is City of Gilbert.
2. The Executive Director is authorized to execute a bill of sale to the above Entity of Government for said equipment, furniture, fixtures, or other items.
3. The District is further authorized to notify the Entity of Government of the District Board of Directors action and to furnish each entity with a signed resolution, and bills of sale which will then constitute the final transfer of title for Economic Development Administration excess federal property under P.L. 49-519.

To become effective immediately upon passage hereof.
