DRIVEWAY PERMIT STANDARDS

Who must comply with Driveway Occupancy Permits?

Any person, owner and/or contractor proposing the installation of a driveway or access road to a parcel of property from a public roadway.

What must be submitted in order to comply with the Township's requirements?

- 1. Complete and submit the attached application form with the prescribed fee.
- 2. Submit a site plan, drawn to scale, which depicts the following information:
 - Lot or parcel and adjacent lots, roadways, and access drives
 - . Access drive location, grade, materials and drainage plan
 - . Proposed or existing structures

The Plan shall be of sufficient detail to comply with the following Design Standards:


Design Standards

- 1. Adequate sight distance to allow safe movement into or out of the access driveway.
- 2. Drainage culvert installed as appropriate.
- 3. The free movement of normal highway traffic shall not be impaired.
- 4. The driveway shall not create a hazard.
- 5. The driveway will not create an area of undue traffic congestion on the highway.

Specific location restrictions shall include the following:

1. Access driveways shall not interfere with the functioning of highway signs, signals, detectors, lighting, or other devices that affect traffic control.

- 2. The location of a driveway near a signalized intersection may include a requirement that the permittee provide, in cooperation with the Township, new or relocated detectors, signal heads, controller and the like, for the control of traffic movements from the highway.
- 3. Access to a property which abuts two or more intersecting streets or highways may be restricted to only that roadway which can more safely accommodate its traffic.
- 4. The Township may require the permittee to locate an access driveway directly across from a highway, local road, or access driveway on the opposite side of the roadway, if it is judged that offset driveways will not permit left turns to be made safely or that access across the roadway from one access to the other will create a safety hazard.
- 5. An access intended to serve more than three properties or to act as a connecting link between two or more roadways shall be considered as a local road and not a driveway regardless of its ownership. As such, its design must be in accordance with the Township's current standards governing the design of local roads.
- 6. The number and location of entrances which may be granted will be based on usage, interior and exterior traffic patterns, and current policy of the Township.
 - a. Normally, only one driveway will be permitted for a residential property, but more than one driveway may be installed subject to approval by the the authorized official.
 - b. Regardless of frontage, a development may be restricted to a single entrance/exit driveway, served by an internal collector road separated from the traveled way.
 - 7. Driveway approaches shall conform to the following standards:
 - a. The location and angle of an access driveway shall be such that a vehicle entering or leaving the driveway ay do so in an orderly and safe manner and with a minimum of interference to highway traffic.
 - b. Flaring of the approach may be required to allow safe, easy turning of vehicular traffic.
 - c. Where the highway is curbed, driveway approaches shall be installed $1\frac{1}{2}$ inches above the adjacent highway or gutter grade to maintain proper drainage.
