As always, we cannot thank the Douglas County Sites and attendees enough. Without them, we would not be able to provide the recycling services that so many residents utilize.



RECYCLING BASICS

Plastics (1, 2, & 5 only), flatted cardboard, newspapers, food and beverage cans, and glass bottles are all recyclable at your local recycling site for free of charge. Other items such as appliances, tires, electronics, and bulbs are also recyclable. Contact your local town recycling site to see what they do and don't accept. Below are some options for recycling if your site doesn't accept these items:

Afterlife Electronics accepts appliances, computers, TVs, electronics, & fluorescent bulbs. They are located at 915 John Ave,, Superior WI. Call 218-940-9274 for hours of operation. https://www.coreadvantage.online/

Vape & E-Cigarette Disposal

Vapes and e-cigarettes will be accepted at the Cleansweep events this year. Disposal of these items will be **free** to residents. Businesses, school districts, health departments, etc. will have to pay a fee.

HOUSEHOLD HAZARDOUS WASTE (HHW)

CLEANSWEEP WILL ACCEPT:

Household hazardous waste will be accepted at the below locations and only at the designated time. Items will be taken for free from residential properties, with the exception of fees charged for bulbs and batteries. Acceptable items include materials such as oil based paints, aerosol spray paints and lubricants, solvents, pesticides, fertilizers, household and hazardous cleaners, corrosives, flammables, mercury, lead tackle and shot, old gas, antifreeze, and other chemicals you wouldn't consider dumping. Mercury containing thermostats, switches and thermometers, and lead based paint will also be accepted for free. Unwanted Rx will be taken for free. Waste Management, the Douglas County Recycling firm contracted to collect recycling, currently accepts residential plastic food/water containers numbered 1, 2, & 5. In the future, the availability of certain numbered plastic containers may be eliminated from the recycling stream due to limited or no markets to recycle some plastics. Should a specific numbered plastic be identified as no longer acceptable, citizens will be informed of the changes via social media, recycling collection sites, and future recycling newsletters.

*Businesses are not allowed to use the recycling containers as DNR funding does not allow it.
