



To Whom it May Concern:

Attached is an application for Snowplowing. If you want the town to plow, please complete the application and mail it back before **Oct 15**.

The current rate is **\$150**, any application received after Oct 15th will cost **\$200, a \$50 difference**. This will help in planning and scheduling of snow-plowing routes.

Main roads will be plowed before driveways. Town will not plow driveways unless there is at least 4 inches of snowfall. **NO** plowing will be done in the fall or spring if the ground is not frozen, unless there is an emergency, as it can damage the driveway.

Your driveway must be a **minimum of 20 feet wide, clear of obstructions (tree branches, power lines, etc.), have adequate turn around space, and have a vertical clearance of 16 feet**. The Town will not be responsible for any items left in driveways and reserves the right to refuse service if specifications are not met. These specifications also very important for adequate clearances for emergency vehicles such as ambulances, fire trucks, etc.

The minimum specifications for your driveway to be plowed are:

- **Width: a minimum of 20 feet wide, clear of tree branches and power lines**
- **Height: a vertical clearance of 16 feet.**
- **Adequate turn-around space**

These minimum specifications are not only important for plowing equipment but also firefighting equipment. Our fire department has indicated clearance issues have become a big concern for accessing property in case of a fire or other emergency.

Thank you for your consideration in submitting your application before Oct 15th and making any necessary modifications to your driveway access.
