AN ORDINANCE MAKING AND LEVYING A SPECIAL ASSESSMENT UPON ALL LOTS, PIECES, AND PARCELS OF GROUND IN THE CITY OF CHERRYVALE, KANSAS, LIABLE FOR THE COST AND EXPENSE OF MOWING AND CUTTING NOXIOUS WEEDS AND DEMOLITIONS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHERRYVALE, KANSAS:

SECTION 1. That a special assessment is hereby levied upon and against the premise in the City of Cherryvale, Kansas, hereinafter described, in the amount set opposite thereto respectively, for the payment of the cost and expense of mowing and cutting noxious weeds and the demolition and cleanup thereon for the Fall of 2015 and the Spring/Summer of 2016.
