PERMIT REQUEST OUTDOOR AMPLIFICATION OF MUSIC

GENERAL INFORMATION

Application Fee

There is no fee for the outdoor amplification of music application.

Allow one month for permit processing

Apply at least 30 days before the event to allow sufficient time to process the permit. Questions about the permit process should be directed to the Town of Scott, Town Hall (920) 406-9380.

Review of Police activity

Staff will review police activity reports at the address for the previous year. All police calls for the property will be forwarded to the Town Board and will be reviewed by the Board prior to the issuance of the Amplification of Music Permit.

The peace and quiet of the neighborhood should not be disturbed by the amplified music from any event; the Brown County Sheriff's Department will enforce the Town's Ordinances. Deputies are authorized to require that amplified music be turned down or turned off, and reserve the right to issue citations accordingly.

Violation of this Permit

Violation of this permit will be a violation of the Town's Nuisance Ordinance:

§ 206-7. Sound amplifiers

- A. The use of sound amplifiers outside buildings within the Town is prohibited without a permit from the Town. A sound amplifier shall not be operated after 10:00 p.m. or before 7:00 a.m. or in the vicinity of churches while services are being conducted, or near schools that are in session. The Town may order a reduction in the volume of an amplifier on complaint being made by a citizen or when such loudspeaker is a nuisance because of volume, the method in which it is being used, at the location in which it is being operated.
- B. Between the hours of 10:00 p.m. and 7:00 a.m., no person may operate a radio, juke box, or other electric sound amplification device emitting sound from any business premises within the Town that is audible on residentially zoned property under normal conditions from a distance of 75 feet or more beyond the lot line of any business premises described which emits a sound, unless the electric sound amplification device is being used to request assistance or warn against unsafe conditions.
