 - General liability insurance with the Village of Woodburgh as the certificate holder and additionally insured.
 - Worker's compensation with the Village as the certificate holder.
 - Plumber's Competency Certificate.

Fee Schedule:

- Application Fee: \$150.00
- Permit Fee: \$50.00 Per Fixture thereafter.
- Gas Test Fee: \$75.00
- A Maintain Permit Is **Double** the Permit Fee.
