OPERATORS LICENSES

The Town of Grant may issue an operators' license if the applicant applies, in writing, meets the requirements of Chapter 125, Wis. Stats., any applicable Town of Grant requirements, and after payment of a non-proratable fee determined by the Town of Grant Board annually for a one-year period to end on June 30. An applicant denied an operators' license shall not be eligible for a refund of the non-proratable fee. An operator's license will not be issued to any person who has been denied an operator's license by the Town of Grant, any other Municipality, the State of Wisconsin or who has had an operator's license revoked or suspended within the preceding twelve (12) months by any of the previously listed entities. The Town of Grant will revoke an operator's license if it is determined that the holder of the license made a false statement on his/her application. An operators' license shall not be issued to anyone convicted of a felony.

MINORS HOLDING LICENSES

A person under the age of twenty one (21) may hold a license only under the provisions of the State of Wisconsin Statutes and the following conditions:

- 1. No record of alcohol use evident in background check.
- 2. No record of drug use evident in background check.
- 3. No felony convictions.
- 4. No license will be issued to a person under the age of twenty one (21) with any of these convictions on their background check for a period of one (1) year or until the age of twenty one (21) whichever is longer.
- 5. No person with a felony conviction can hold any alcohol licenses in the Town of Grant.

TRAINING REQUIREMENTS FOR LICENSING

Training Course. A license shall not be issued to any applicant unless the applicant has successfully completed a responsible beverage server training course at a location that is offered by a vocational, technical, and/or adult education district and that conforms to curriculum guidelines specified by the board of vocational, technical, and adult education of the State of Wisconsin or a comparable training course that is approved by the State of Wisconsin or unless the applicant fulfills one of the following requirements;

- 1. The person is renewing a manager's or operator's license.
- 2. Within the past 2 years, the person held a Class "A", Class "B", "Class A", or "Class B" license or a manager's or operator's license.
- 3. Within the past 2 years, the person has completed such a training course.
- 4. Where application is made for a license on behalf of a sole proprietorship; the sole proprietor shall have successfully completed the Beverage Server Training Course. Where such application is made on behalf of a partnership, all partners shall have successfully completed the Beverage Server Training Course. Where such application is made on behalf of a corporation or a limited liability company, the agent appointed shall have successfully completed the Beverage Server Training Course.

All <u>new</u> applications for operator's licenses must be approved by the Grant Town Board. The board meets regularly on the 1st Monday of each month at the Grant Town Hall. Applications and fees must be returned to the Town Clerk ten (10) days prior to the 1st Monday of the month to allow adequate time for background checks and subsequent approval at the town board meeting. To avoid delays, please be sure to provide the following items when applying:

- $\sqrt{}$ Completed Application for Operator's License
- $\sqrt{12.00}$ fee payable to the Town of Grant
- $\sqrt{10}$ Proof of completion of Beverage Server Training Course OR
- $\sqrt{}$ Copy of retail, manager, or operator's license held in State of Wisconsin within last two years
