Treasurer's report was given. Beginning Balance Jan. 1, 2023, was \$3,104.95, Income for 2023 was \$659758.86 and Expenses for 2023 were \$656716.65. Ending Balance Dec. 31, 2023, was \$3,042.21. Additional Available Funds: Fire District Savings Account \$20,856.96, CD Amount \$51,652.37, Equipment Fund Savings \$36,502.17, Highway Reconditioning Fund \$84,056.72, Building & Grounds \$16,343.99, CD Amount \$51,652.37. Total Available Funds \$264,106.79 Town Levy for 2024 is \$41,118.00.

Clerk Lori Czubakowski reviewed the Annual Financial Report on a page-by-page basis.

There was a motion by Kevin Knox, 2<sup>nd</sup> by Jerry Czubakowski to approve the Annual Report. All hands raised.

There was a motion by Darrell Thompson, 2<sup>nd</sup> by Kevin Knox to use The Thorp Courier for our official paper, Superior Credit Union as our main bank, as much as possible meetings will be on the 3<sup>rd</sup> Tuesday of each month at 7pm. All hands raised.

New Agenda Items:

Elector asked why Sunset was posted as a Lane not Drive? Chairman responded when sign was ordered both names came up and Lane was chosen.

Why was the marred sign on County Line, not replaced or removed. Chairman responded because it is still a Class B Road.

Elector asked why wasn't the Annual Report available during Spring Election? Clerk responded yes it was there were 20 copies on the back table and many other electors picked them up. There were still 5 available on the table at the start of this meeting.

The Elector asked why wasn't South end of the township graded yet this spring? Chairman responded, grading just started Saturday. About the washboard? Chairman responded we will try to do better.
