**FINDINGS, DECISION AND ORDER FOR AMENDING THE ORDER CREATING
PIKE'S BAY SANITARY DISTRICT**

WHEREAS, the Town Board for the Town of Bayfield enacted an order dated the 28th day of January, 1977, creating the Pike's Bay Sanitary District, which order has been duly recorded with the Register of Deeds for Bayfield County in Vol. 298 of Records, pages 268-269 inclusive, as Document Number 311896; and

WHEREAS, on January 18, 1993, the Town Board for the Town of Bayfield received a petition of the L. R. Reinstra Self-Employed Retirement Trust for the addition of property located wholly within the Town of Bayfield to the Pike's Bay Sanitary District ("the subject property"), the description of which is set forth in the order below; and

WHEREAS the petition met the requirements of Section 60.785 and 60.71(2) Stats.; and

WHEREAS the Town Board for the Town of Bayfield held a hearing upon said petition on March 5, 1993, as required by Section 60.785 and 60.71(4) Stats. upon the notice required by Section 60.71(4)(b) Stats.;

NOW THEREFORE the Town Board of the Town of Bayfield makes the following findings, decision and order:

FINDINGS AND DECISION

1. The proposed work is necessary.
2. The public health, safety, convenience and welfare will be promoted by the addition of the subject property to the District.
3. The subject property will be benefitted by being included in the District.
4. For the above reasons, the subject property should be included in the District.

ORDER

NOW THEREFORE, IT IS ORDERED that the order dated January 28, 1977, be amended to add the following described property to the Pike's Bay Sanitary District:

PARCEL 4: All that part of Government Lot Four (4), Section Twenty-three (23), Township Fifty (50) North, Range Four (4) West, which lies South and East of the Southerly right-of-way line of the Chicago and Northwestern Transportation Company, now abandoned, in Bayfield County, Wisconsin,

- and -

PARCEL 6: A strip of land 145 feet in width, lying 95 feet Northerly and Westerly and 50 feet Southerly and Easterly of the center line of the abandoned right-of-way of the Chicago and Northwestern Transportation Company in Government Lot Four (4) of Section Twenty-three (23), Township Fifty (50) North, Range Four (4) West, Bayfield County, Wisconsin.


