ALL—TERRATN VEHTCLE ORDINANCE

Pursuant to Section 23.33(8) and (11) of the Wisconsin Statutes, the Town Board of the Town of Bayfield, Bayfield County, Wisconsin, does hereby ordain as follows:

- Section 1. Purpose. The purpose of this ordinance is to establish all-terrain vehicle (hereby "ATV") routes within the Town of Bayfield and regulations for the operations of ATVs thereon.
- Section 2. Applicability and Enforcement. The provisions of this ordinance shall apply to all town roads within the Town of Bayfield, and shall be enforced by any of those officers authorized to do so under Section 23.33(12) of the Wisconsin Statutes.
- Section 3. <u>Designated Routes</u>. The entire lengths of the following town roads within the Town of Bayfield are hereby designated ATV routes

Gotchlin Road
Echo Valley Road
Henkins Fire Lane
Jammer Hill Road
Menard Road
Olson Road off Menard
McCutcheon Fire Lane
Weidinger Road
Sand Pit Road
Gravel Pit Road
Butterfield Road

All other roads, except Deerfield Road, Ski Hill Road, and Betzold Road, out open but only for access from the properties adjoining such roads to other designated ATV routes by the shortest and most direct route.

Section 4. <u>Signs.</u> Each designated ATV route shall be marked by signs having relectorized white AV symbols, bordered and with messages on reflectorized green backgrounds with minimum sizes of 24 inches by 18 inches, with directional arrows where appropriate, placed at the beginnings of the designated routes and at such locations and intervals as are necessary to enable ATV operators to follow the routes. Access routes shall be further marked "Access Route Only" and Deerfield, Ski Hill, and Betzold Roads shall be marked "No ATVs Allowed."

Section 5. Operation. Any ATV being operated on a designated ATV route shall be operated on the extreme right hand side thereof; shall not exceed a speed of 25 mph; and shall display a lighted head lamp and tail lamp at all times during such operation.

Section 6. Incorporation of Statutes. The provisions of Section 23.33 of the Wisconsin Statutes are incorporated herein by reference.

Section 7. Effective Date. This ordinance shall take effect upon passage and publication.

All other roads, except town roads in Deerfield Estates, Ski Road, and Betzold Road, but only for access from the properties oining such roads to other designated ATV routes by the shortest ad most direct route:

Section 4. Signs. Each designated ATV routes shall be marked by signs having reflectorized white ATV symbols, bordered and with messages on reflectorized green backgrounds with minimum sizes of 24 inches by 18 inches, with directional arrows where appropriate, place at the beginning of the designated routes and at such locations and intervals as are necessary to enable ATV operators to follow the routes. Access routes shall be further marked "Access Route Only" and town roads in Deerfield Estates, Ski Hill, and Betzold Roads shall be marked "No ATVs Allowed."

Section 5. Operation, Any ATV being operated on a designated ATV route shall be operated on the extreme right hand side thereof; shall not exceed a speed of 25 mph; and shall display a lighted head lamp and tall lamp at all times during such operation.

Section 6. <u>Incorporation of Statutes</u>. The provisions of Section 23.33 of the Wisconsin Statutes are incorporated herein by reference.

Section 7. Effective Date. This ordinance shall take effect upon passage and publication.
