

ORDINANCE NO. 2003-03

**AN ORDINANCE ESTABLISHING A BOARD OF REVIEW
FOR THE TOWN OF BAYFIELD**

WHEREAS, §70.46(1m)(a), Wisconsin Statutes, provides a person who is appointed to the office of Town Clerk, Town Treasurer or to the combined office of Town Clerk and Town Treasurer under §60.30(1e), may not serve on a board of review under Sub. (1), and

WHEREAS, the Town Board of the Town of Bayfield desires to have its appointed Town Clerk serve as a voting member of the Board of Review, and

WHEREAS, §70.46(1), Wisconsin Statutes, allows for the establishment, by ordinance, of a board of review consisting of a specified number of residents of the Town, which may include public officers and public employees,

NOW, THEREFORE,

The Town Board of the Town of Bayfield does ordain as follows:

1. There is hereby established for the Town of Bayfield (in Bayfield County, Wisconsin), a Board of Review which consists of six (6) residents of the Town of Bayfield, which may include public officers and public employees.
2. Initially, in order to create staggered terms, two (2) individuals shall be appointed to the Board of Review to serve a one-year term, two (2) individuals shall be appointed to the Board of Review to serve a two-year term, and two (2) individuals shall be appointed to the Board of Review to serve a three (3) year term. Thereafter, each member's term shall be for three (3) years. Appointments to the Board of Review shall be made by the Town Board. In the event of a vacancy on the Board of Review, a person shall be appointed by the Town Board to fill the balance of the unexpired term.
3. If an individual member of the Board of Review receives a salary from the Town of Bayfield for other service to the Town, such individual shall receive no additional compensation for serving on the Board of Review. If an individual member of the Board of Review does not receive a salary from the Town of Bayfield for other service to the Town, such individual member of the Board of Review shall receive the amount of \$50.00 for each Board of Review meeting he or she actually attends. This compensation may in the future be fixed by resolution of the Town Board.
4. The following residents of the Town of Bayfield are hereby appointed to serve the following terms on the Board of Review which is hereby established for the Town of Bayfield:
 - a. Jane Hauser and William Ferraro are appointed for an initial one (1) year term.
 - b. James Erickson and Richard Compton are appointed for an initial two (2) year term.
 - c. Thomas Gordon and Gerald Carlson are appointed for an initial three (3) year term.

Future appointments to the Board of Review may be made by resolution of the Town Board.

5. As per §60.80(1), Wisconsin Statutes, within thirty (30) days of this ordinance being adopted, the Town Clerk shall publish as a Class 1 notice under Chapter 985, or post in at three (3) places in the Town likely to give notice to the public, a copy of this ordinance.
6. As per §60.80(3), Wisconsin Statutes, this ordinance shall take effect the date after its publication or posting.
