#### **ORDINANCE 2022-02** Golf Cart Ordinance

The Town Board of the Town of Bayfield does ordain as follows:

Section 1: Title. This ordinance is entitled the Town of Bayfield Golf Cart Ordinance

Section 2: Purpose & Authority. The purpose of this ordinance is to regulate the use of Golf Carts on public highways within the Town of Bayfield pursuant to Wis. Stats. § 349.18.

### Section 3: Definitions.

- A. "Golf Cart" means a vehicle designed and manufactured for operation on a golf course for sporting or recreational purposes and that is not capable of exceeding 20 miles per
- B. "Highway" is defined as stated in Wis. Stats. § 340.01(22).

Section 4: Public Roadway Crossings. Persons operating golf carts within the Town of Bayfield shall only cross a highway at locations and under the conditions specifically authorized in this Ordinance:

- A. All golf cart crossing points shall be designated as such by appropriate signage approved by the Department of Transportation.
- B. Any person operating a golf cart must fully stop and yield the right-of-way to all vehicles approaching on the highway prior to crossing said highway.
- C. Trailer Court Road: Golf Carts may cross Trailer Court Road where it intersects the campground's private roads Madeline Island Way and Stockton Island Lane.
- D. This ordinance shall not prohibit golf carts crossing of at a designated golf-cart crossing point within the Apostle Highlands Golf Course when the operators of such golf cart are actively engaged in playing golf, or otherwise using the golf carts for golf-related purposes.

#### Effective Date:

The foregoing Ordinance shall be deemed to be in force from and after its passage, approval, posting, publication and recording according to law.
