**ORDINANCE 2013-06**

**ALL-TERRAIN ATV/UTV VEHICLE ORDINANCE**

Pursuant to §23.33(8) and (11) Wisconsin Statutes, the Town Board of the Town of Bayfield - Bayfield County, Wisconsin, does hereby ordain as follows:

**Section 1. Purpose.**

The purpose of this ordinance is to designate all-terrain vehicles (hereinafter "ATV/UTV") routes within the Town of Bayfield and enact regulations for the operation of ATV/UTVs thereon.

**Section 2. Applicability and Enforcement.**

This ordinance shall apply to all town roads within the Town of Bayfield, and shall be enforced by any of those officers authorized to do so under §23.33(12) Wisconsin State Statutes.

**Section 3. Designated Routes.**

The following portions/lengths of the following town roads within the Town of Bayfield are hereby designated ATV/UTV routes:

1. Betzold Road.
2. Butterfield Road.
3. Echo Valley Road.
4. Gotchling Road.
5. Gravel Pit Road.
6. Hatchery Road (from Weber Road to CTH J only).
7. Henkens Road (Star Route Rd to McCutcheon Rd)
8. Jammer Hill Road.
9. McCutcheon Road.
10. Menard Road.
11. Eagle Island Road (to NPS Boundary).
12. North Branch Road (to NPS Boundary).
13. Compton Road.
14. Sand Point Road (to NPS Boundary).
15. Star Route Road (CTH J to Town of Bell Boundary).
16. Valley Road.
17. Weber Road.
18. Torbick Road.
19. Meyers-Olson Road.
20. Happy Hollow Road.

Each designated ATV/UTV route shall be marked by signs having reflectorized white ATV/UTV symbols, bordered and with messages on reflectorized green backgrounds with minimum sizes of 24 inches and 18 inches, with directional arrows where appropriate, placed at the beginnings of the designated routes and at such locations and intervals as are necessary to enable ATV/UTV operators to follow the routes. Included among these will be a sign indicating ATVs are allowed posted at the Town of Bayfield sign at the west end of Star Route.

### Section 5. Emergency Closures.

The Town Board may take action to temporarily close any designated ATV/UTV route or portion thereof for a specified period of time if the Board determines that a safety or detrimental environmental situation warrants such closure.

### Section 6. Operations Restrictions.

Any ATV/UTV being operated on a designated ATV/UTV route shall be operated on the extreme right hand side thereof; shall not exceed a speed of 25 mph; shall display a lighted head lamp and tail lamp at all times during such operation; and shall be closed from 10 p.m. to 5 a.m.

### Section 7. Incorporation of Statutes.

The provisions of §23.33 Wisconsin Statutes are incorporated herein by reference.




### Section 9. Effective Date.


This ordinance shall be effective upon its passage and publication and signage of the designated routes.




