## **ORDINANCE NO. 46**

#### REGULATE THE STORING OF JUNKED AUTOMOBILES

The Village Board of the Village of Cochrane, Buffalo County, Wisconsin, do ordain as follows:

- 1. No person, firm, partnership or corporation shall accumulate or store any junked automobiles or parts thereof outside of any building on any real estate located within the corporate limits of the Village of Cochrane, except upon a permit issued by the Village Board of the Village of Cochrane.
- 2. The permit issued by the Village Board shall be signed by the President and the Clerk of the Village of Cochrane and shall specify the quantity and manner of storing such junk. Such permit shall be revocable at any time by the Board after a hearing at which it has been found that the permit holder has failed or refused to comply with this Ordinance. Such hearing may be held by the Village Board of the Village of Cochrane upon its own motion or upon the complaint in writing, duly signed and verified by a complainant. Such complaint shall show the nature of the alleged failure to comply with such order or regulation. A copy of the complaint, together with a notice of the hearing, shall be served upon the permit holder not less than ten days previous to the date of hearing.
- 3. Any person violating any of the provisions of this Ordinance shall forfeit to the Village of Cochrane a sum not less than Ten (10) Dollars nor more than Fifty (50) Dollars for each offense. Each day that junk, as herein defined, shall be stored contrary to the provisions hereof, shall be considered a separate and distinct violation of this Ordinance.
  - 4. This Ordinance shall be effective upon passage and publication.

# ORDINANCE NO. 46-AMENDMENT A

## REGULATE THE STORING OF JUNKED AUTOMOBILES

The Village Board of the Village of Cochrane, Buffalo County, Wisconsin, do ordain as follows:

This amendment shall be made to Ordinance No. 46 in defining the word/term "Junk and/or junked automobiles"

The word or term "Junk or Junked Automobiles" shall mean any vehicle that does not have a current registration.

This amendment shall be effective upon passage and publication.

### ORDINANCE NO. 46-AMENDMENT B

#### REGULATE THE STORING OF JUNKED AUTOMOBILES

The Village Board of the Village of Cochrane, Buffalo County, Wisconsin, do ordain as follows:

The following amendments shall be made to paragraph 2, in relation to the issuance of permits:

- **2A.** A permit shall be required for each vehicle that is being requested by the owner for an exemption from the ordinance. A permit shall be issued two (2) times only per vehicle and verified by the vehicle identification number.
- **2B.** The applicant shall pay a ten (\$10.00) dollar fee for each permit and is due at the time the permit is applied for.
- **2C.** The permit shall expire three (3) months from the date of issue, and may be renewed one (1) time only.
- **2D.** Following passage and publication, Ordinance #46 and its amendments shall be named "Regulate the Storing of Unregistered Automobiles."

This amendment shall be effective upon passage and publication.
