ANNUAL TOWN MEETING APRIL 10, 2012

Chairman Eugene Mertz called the 2012 Annual Meeting of the Town of Rantoul to order at 7:30 p.m. with the Pledge of Allegiance. Eight residents and guests were in attendance, along with Board Members Eugene Mertz, David Jannette, Gregg Eickert, Mary Schwartz and Connie Loose. Chairman Mertz verified that meeting notices were published and posted.

The agenda was reviewed. Motion by David Jannette, second by Wes Hedrich to accept the agenda as printed and posted; motion carried by voice vote. A copy follows.

The minutes from the 2011 Annual Meeting and 2011 Special Budget Meeting were next on the agenda. Motion by Gregg Eickert, second by David Jannette to dispense with the reading of the minutes and to approve the minutes as printed in the 2011 Annual Audit Report mailed to the Town residents; motion carried by voice vote.

The 2011 Annual Financial Report was discussed. Motion by Wes Hedrich, second by Mark Wunrow to approve the 2011 Annual Financial Report; motion carried by voice vote.

David Dhein, assessor, sent in the following report:

According to state law, if your equalized value falls below 90%, or above 110%, the four year cycle starts, where the Department of Revenue will require a reassessment. In 2004 we did drop below 90% to 84.51% of market value. In 2009 we had a reassessment of the Town. The assessed value for the Town was at 102.11%. In 2010 the equalized value of the Town is 100.83%. In 2011 the equalized value of the Town went to 106.06%. If sales keep decreasing in value we may need to change assessments to follow the market. In 2011 we had \$265,000 of new construction.

Motion by David Jannette, second by Dennis Hintz to designate Collins State Bank, Calumet County Bank-Brillion and State Bank of Chilton as our public depositories; motion carried by voice vote.

Mark Wunrow gave a Road Report. Hilbert Road between County Road PP and Schneider Road is being looked at for work and other roads as the budget permits.

Motion by Gregg Eickert, second by David Jannette that the Board has short-term (loan to be repaid by the end of the year) borrowing power not to exceed \$50,000.00; motion carried by voice vote.

Motion by Mark Wunrow, second by Wes Hedrich that the Board has long-term borrowing power not to exceed \$150,000.00; motion carried by voice vote.

Due to the change in election laws, the Board members elected at the April election will take office one week later than has been the case. An ordinance has been adopted and posted extending the terms of the present Town Board one (1) week to account for the change. The state-wide date for the Town's Annual Meeting was also moved one week later. Motion by David Jannette, second by Gregg Eickert to set the 2013 Annual Meeting for Tuesday, April 16, 2013, at 7:30 p.m.; motion carried by voice vote.

The contract with the Potter Volunteer Fire Department was changed at the end of 2011. The contract reimbursement was increased to include the purchase of equipment. The Town will no longer be purchasing equipment for the Fire Department. The contract was also changed from a one (1) year contract to a three (3) year contract.

The Town of Rantoul Zoning Ordinance and Zoning Map was approved by DATCP, recommended by the Town of Rantoul Plan Commission for adoption, adopted by the Town Board of the Town of Rantoul and approved by the Calumet County Board of Supervisors at the end of 2011. Eugene Mertz is the Zoning Administrator. The forms and ordinance can be found on the Town's website.

There being no other business, motion by Mark Wunrow, second by Wes Hedrich to adjourn; motion carried by voice vote.

Discussion was held on the various budget items. Motion by Gregg Eickert, second by David Jannette to close the hearing portion of the meeting; motion carried by voice vote.

Chairman Mertz called the Special Town Meeting to order at 7:15 pm. He verified that meeting notices were posted and published. Mary Schwartz confirmed that notices were posted on October 29, 2012 and published in the Chilton Times-Journal October 22 and November 1, 2012.

Changing the monthly Board meeting day from the first Monday of the month to the second Monday or Tuesday of the month was discussed. Motion was made by Gregg Eickert and seconded by David Jannette to change the monthly Town Board meeting day to the second Monday of the month beginning with the January 2013 meeting with the regular monthly payroll paid the first of the month; motion carried by voice vote.

Compensation of the elected official officials for the term of office to begin April 2013, pursuant to Section 60.32 of Wis. Statutes was next on the agenda. Motion by Mark Wunrow, seconded by Mary Schwartz to set the compensation as follows:

Town Chairperson \$3,600.00 annually

Town Supervisor \$1,800.00 annually (no change)

Town Treasurer \$5,500.00 annually;

motion carried by voice vote.

Motion by David Jannette, second by Gregg Eickert, pursuant to Section 60.10 (1)(a) of Wis. Statutes, to adopt Resolution 2012-06, a Resolution for Electors to Adopt the Town Tax Levy at Special Town Meeting of the Electors, setting the town tax levy for 2012 to be collected in 2013 at \$245,598.76; motion carried.

ZONING (BUILDING), CONDITIONAL USE PERMITS

The TOWN OF RANTOUL has adopted Ordinance 2011-06 – The Town of Rantoul Zoning Ordinance and Zoning Map. Zoning (building) Permits and/or Condition Use Permits are required for projects over \$3,500. Application for permits may be made to the Zoning Administrator, Eugene Mertz, or to the Assistant Zoning Administrator, Mark Wunrow. Application forms and fee schedules are available on the Town website. The TOWN OF RANTOUL has also adopted the Wisconsin Uniform Dwelling Code which requires inspection of all new construction of one-and-two family dwellings and alterations over \$25,000.00 value to one-and-two family dwellings built since June 1, 1980. Building permits for construction covered by the WI UDC shall be obtained from Birschbach Inspection Services.

TOWN MEETINGS

Beginning in January 2013, the regular monthly Town Meetings will be held on the second (2nd) Monday of each month at the Potter Village Hall. Meetings will begin at 7:00 p.m. Special meetings to be held will have published notices in the Chilton Times Journal. Meeting notices and agendas will be posted at the Potter Village Hall, Gruetts, the Town Garage and Potter Post Office (when needed). Agendas and meeting change notices can also be found on the Town's website – www.townofrantoul.com.

DOGS

All dogs in the TOWN OF RANTOUL shall be licensed and have all required shots. Charges are \$3.00 for spayed or neutered, and \$8.00 for others. Please have your dog vaccinated before applying for a license. A late fee of \$5.00 shall be assessed to the owner of each dog 5 months of age or older, who fails to obtain a license by April 1st. Licenses are issued by the Town Treasurer, Connie Loose. Please have your proof of vaccination with you when applying for this license.

NOTE: If a person neglects to pay a dog fee on his dog, his claim for dog damages will not be paid. Fines may also be assessed.
