Public Plaza Meeting

Thoughts and considerations for a "Plaza" development, within the town of Boulder Jct.

Our town now.

A. Appearance: Well maintained---"clean" appearing. Warm, small town--- comforting. Business owners take pride in their facilities and surroundings.

B. History: Logging, fishing, hunting, and other outdoor offerings and usages. Railroad pickup and drop off site. The train depot was a wagon pickup site for guests, and was provided by some of the outlying resort facilities.

C. Boulder Jct., has capitalized on its unique outdoor activities and offerings.

D. Future: Continue to maintain and develop the attractions that have drawn "guests" to our township. Bring forward, improve, AND implement the furtherance of the established, and enjoyed, activities for residents and "guests".

E. Cautions, Considerations, and Awarenesses: "Over enthusiasm", resulting in "problems" Does our community want to evolve into a Wisconsin Dells or Key West, Florida, attraction? Will what works for those, "attractions", work, or be acceptable within our community?

F. The "attractions" offered to draw "guests", may, and often do, require some type of "monitoring" or controls, to prevent unacceptable "actions" by participants. Boulder Jct., at one time in its history, had a constable, that was then followed by a full time police officer. Those town positions are no longer in place. Law enforcement, crowd control, check points and physical barrier needs, should be reviewed.

G. Who or what group, will address the potential "side effects", positive and negative, of these new "attractions? This must be considered. Various news "media", have

stated, "that we are living in a more problematic, and chaotic times".

H. What local, established town organizations, would consider involvement in proposed, new "attractions? These organization should be contacted.

I. Who or what organizations will develop, supplement and monitor these proposed "attractions?

J. Consider the concept to 'start slow', and let the process grow----successfully.
