**ORDINANCE NO. 2010-O-07**

**An Ordinance Amending Ordinance 3-71 a Snowmobile Trail Ordinance**

WHEREAS, the Town of Boulder Junction has, pursuant to Section 350.04 (2) of the Wis. Stats., power and authority to designate streets marked as snowmobile routes; and

WHEREAS, the Town Board passed Ordinance 3-71 on October 19, 1971 and subsequent amendments 1-16 passed since then and through December 20, 2005; and

WHEREAS, an existing temporary easement has been forfeited by a property owner causing hardship to access The Outdoorsman Restaurant and Motel; and

WHEREAS, The Outdoorsman Restaurant and Motel would gain access to the trail upon adoption of an amending this Ordinance to allow trail traffic from the intersection of Ada Street and Blaisdell Street continuing north on Ada Street for approximately 100 yards to the entrance of an access trail that leads to these establishments; and

WHEREAS, amendments 14, 15, and 16 are also being corrected with this Ordinance; and

THEREFORE, BE IT ORDAINED by the Town Board of the Town of Boulder Junction, Vilas County, Wisconsin, that Section 1 of Ordinance 3-71 is hereby amended to read:

- "~~X~~. **Y.** That part of Anns Place from Old Cty K East south to its Junction with the driveway of Trout Lake Unlimited (Coontail) property (approximately 335 ft.). This designated route is located in Section 20, Township 42, Range 7." *(adopted 12/4/2003 Amendment #14)*
- "~~X~~. **Z.** 315 feet of Green Street to Annes Place and 280 feet of Annes Place as snowmobile route in Section 20, Township 42, Range 7." *(adopted 12/20/2005 Amendment #15)*
- "~~X~~. **AA.** .4 mile of Little Crooked Lane and 1.3 miles of Bear Lake Road to the intersection of East Keego Road in Section 2, Township 42N, Range 6E." *(adopted 12/20/2005 Amendment #16)*


BE IT FURTHER ORDAINED, that Section 1 of Ordinance 3-71 is hereby amended to include the following sections of road in the schedule of designated town roads which may be used as snowmobile trails:


"AB. Beginning at the intersection of Ada Street and Blaisdell Street, continuing north on Ada Street for approximately 100 yards. This designated route is located in Section 20, Township 42N, Range 7E." (*Amendment #17*)


This Ordinance shall take effect from and after its passage and upon publication.

The foregoing Ordinance was adopted at a special meeting of the Town Board of Boulder Junction on the 10th day of December, 2010.
