LINN, WALWORTH COUNTY, WISCONSIN, S. 9-7 SPEED LIMITS (B)(D)

§ 9-7 Speed limits

B. Twenty-five miles per hour. Twenty-five miles per hour on:

- (1) Basswood Drive.
- (2) Harwood Drive.
- (3) Cisco Road.
- (4) Oriole Road.
- (5) Knollwood Drive.
- (6) Chapin Road.
- (7) Blackpoint Road.
- (8) Elgin Club Road.
- (9) Fair Oaks Road.
- (10) Lackey Lane.
- (11) Hillside Road north of South Lakeshore Drive.
- (12) Laurel Street.
- (13) Maple Ridge Road north of Blackpoint Road.
- (14) Oakwood Drive.
- (15) Southland Lane.
- (16) South Land Road.
- (17) South Street.
- (18) Snake Road.
- (19) Wooddale Drive.
- (20) Mill Road.
- (21) Zenda Road from Highway B south to south of railroad.
- (22) Linn Road from South Lakeshore Drive to Sunnyside Drive to official sign for 25 miles per hour from Memorial Day through Labor Day; 35 miles per hour the remaining days of the year.
- (23) South Lakeshore Drive between the intersection of North Creekside Lane and the Village of Fontana-on-Geneva Lake.
- (24) South Lakeshore Drive from the southerly most point of the Big Foot Beach to Swinghurst Lane.
- (25) Washington Avenue.
- (26) Williams Plaza.
- (27) Geneva Ave.
- (28) Lincoln Ave.
- (29) Longolier Place.
- (30) Lortin Lane.
- (31) Lakeview Avenue.
- (32) 1st Street

(33) 2nd Street

(34) 3rd Street

(35) Oakrest Avenue

(36) Linnwood Avenue.

(37) Glenmore Avenue

C. Thirty-five miles per hour. Thirty-five miles per hour on:

(1) Academy Road.

(2) Hillside Road south of S Lakeshore Drive to County Highway B.

(3) Maple Ridge Road north of South Lakeshore Drive.

(4) Linton Road from the intersection of South Lakeshore Drive and Willow Road westerly to Brink Road.

D. Forty miles per hour. Forty miles per hour on:

(1) South Lakeshore Drive between the intersection of North Creekside Lane and Swinghurst Lane.

(2) Linton Road between the eastern- and westernmost signs designating the Linton unincorporated limits.


