

MUD HEN LAKE REHABILITATION DISTRICT MEETING

8/8/2020

Meeting was called to order at the Daniels Town Hall on Saturday, 8/8/2020 at 1 PM by Mike Huber with 33 members in attendance. Mike shared that the agenda item of Electing an Official to the Board was left off the agenda. Motion was made to approve adding the item to the agenda by Russ Unger. Motion was seconded by Jim Strub. Motion carried.

Secretary's report was read by Mary Sagstetter. Motion was made to approve Secretary's report by Russ Unger. Motion was seconded by Val Strub. Motion carried.

Treasurer's report was read by Kandy Unger.

Current balances: Checking: \$594.94 Savings: \$10,189.50 Total of \$10,784.44

Motion was made to approve Treasurer's report by Val Strub. Motion was seconded by Bill Burton. Motion carried.

Old Business:

1. **Purple Loosestrife** – Mike Huber thanked all the volunteers that assisted in harvesting the Purple Loosestrife from the lake, this morning before the meeting. There was a turnout of 27 volunteers from the Mudhen Lake association – which was a great turnout! 17 large black garbage were filled with the Purple Loosestrife by the volunteers from the Mudhen Lake association and 3 volunteers from Burnett County – Tom Boisvert and his two volunteers.

Discussion occurred as to the areas impacted with Purple Loosestrife- the largest areas this year where it was present was on the shoreline and boggy area by the Lamfred property and then on the corner of Mudhen Lake Road and Mudhen Lake Dr. In addition, conversation took place about notifying landowners if Purple Loosestrife was taken off their shoreline area or property so they could watch for it in the future.

2. Lake Update –

a. **ILIDS Report** - Mike Huber shared that the 2020 ILIDS report to date was not located to share at the meeting. This 2020 report can be accessed at the following link and is updated continually throughout the year:

b. **Lake Monitoring Report/ Health of the Lake** - Mike Huber shared the information from the Water Quality 2020 Annual report regarding the Water Quality and Clarity. Dan Heintz asked if the report included the oxygen Level. The report pulled from the WI DNR website did not include the oxygen level. Mary Sagstetter, secretary, offered to reach out to Scott Stennes to see if he had been taking the readings and entering the data. Discussion occurred about identifying certain weeds in the lake. Tom

Boisvert suggested that a picture of the weed be taken and sent to him for identification. A request was made to have his contact info added to the minutes.

3. Committee Reports

a. Lake Level Committee Report – Deb Luzinski shared that this committee consists of a representative from each side of the lake.

Deb shared information discovered from the Committee's research and from connecting with the DNR. Over the past several years as far back as 1937, and on two different occasions the previous landowner gave permission to put a structure in outlet on the west side of the lake to regulate the water flow. Yet nothing happened. The Committee will continue to connect with the DNR to research what steps can be taken to address the lake level. If anyone has questions before next meeting, please contact Deb Luzinski. A report will be provided at the next meeting by the Lake Level Committee with further details.

Mike Huber shared that on July 20th Dan Harrington from DNR Water Management contacted him. Dan reported that he was receiving many calls from MudHen Lake residents regarding the low lake level. Then on August 1, 2020, Mike received information via email between Dan Harrington and Jacob Druffner stated, "residents feel there is an authorized dam at the outlet and that it's DNR's responsibility to ensure water levels are being maintained at certain levels. Email stated that, " a letter would be sent to the Lake Association and the Township to clarify this and verify the following:

1. Is there an authorized dam at this location?
2. If not, we need to verify what is present and notify the landowner that any remnants of the structure need to be removed and supply our beaver damage control pamphlet."

Further communications thru August 5, 2020, discussed lake level being consistent over the years and not showing much fluctuation other than the drought in the 1980's.
Complete email communications will be posted on Town of Daniels website in meeting minutes.

The landowner, Craig Duran, was asked if he would commit to having a structure put on the property and his response was, he would wait to see what the DNR's response is. Mike then suggested the only the Lake Level Committee members should be in contact with the DNR, rather than individual landowners, so the Committee can do their work. Mike also noted that Wild Rice is present on the lake and that information could be useful if the DNR is recommending taking out the structure. It also could impact a permit for a structure to manage the flow of the water. It is possible that if the remaining

structure is taken out that the water, the water will just continuously run out of the lake. At the end of the day all this must go through the DNR. Mike was asked to project what he felt the cost would be for this project, he stated in the millions.

c. Purple Loosestrife - Volunteers were requested to sign up for this committee for next year. No one volunteered. Request will be made at next meeting.

New Business:

1. Tamarack lake Survey Report/Lake Level – Mike Huber shared the Tamarac Land Surveying report for the July 3,2020 Lake level Reading. Lake Elev = 97.3 NAVDD88 Lake ELEV. = 969.5

The survey, that includes lake level readings from each year from 1984 – 2020, is posted on Town of Daniels website in meeting minutes.

Discussion occurred regarding the current lake level. Including that the level goes up with the rain, that we have an inconsistent water level throughout the summer. A question was asked about the number of times the lake level is read and the cost. Answer was one time a year – at roughly the same time and the cost is \$125 / year. Dan Heintz shared how another lake maintains a structure with boards being put on and pulled off. It works to assist with keeping the water in the lake.

2. Audit of the Financials

Kandy Unger, Treasurer, presented the verification document that the Mudhen Lake Association checking account and savings account were reviewed and found to be in order. Dawn Wicklund and Barry Losetter signed the verification on 8/6/2020. Motion was made to accept the audit review. Motion was seconded. Motion carried. This signed document will be posted on Town of Daniels website in meeting minutes.

3. Approve Budget

Mike Huber announced that the Board seat of Treasurer was open. Kandy Unger submitted a letter of intent to run. It was offered to the Members if anyone else was interested in running. Deb Luzinski nominated Dan Heintz. The nomination was seconded by Mr. Herzog. A ballot election was held. Results: Dan Heintz 17 and Kandy Unger 19. Kandy Unger will serve a three-year term in the position of Treasurer.

Mike Huber adjourned the meeting.

I had a conversation with the Chairman of the Town of Daniels (Mike Huber- copied) last week about the dam on Mudhen Lake in Burnett County. Apparently from our discussions, there is a relatively new owner on the property where the dam is located, and also lives on the lake. Attached is a snip it of the property, with the land owner information.

It sounds like maybe there are remnants of the dam still in place when it was supposed to be abandoned before I covered Burnett County. I have never been to this site. Over the years it sounds as if , beavers and other individuals have manipulate with whatever is there now.

I think we need to verify a couple of things:

1. Is there an authorized dam at this location?
2. If not, we need to verify what is present and notify the landowner that any remnants of the structure need to be removed, and supply our beaver damage control pamphlet – attached to the current land owner.

I have spoken with a handful of lake residents who feel there is an authorized dam at the outlet and that it's DNR's responsibility to ensure water levels are being maintained at certain levels.

I think we need to send a letter to the Lake Association and the Town of Daniels so everyone is clear on this issue.

On July 3, 2020, the elevation of Mud Hen Lake was 97.3 feet based on DNR bench 771-D near Lindberg Park. The DNR bench is a brass cap set in a concrete post with an assumed elevation of 103.1 feet (this is a local datum). The water elevation converted to the NAVD88 datum is 969.5 feet. The historic lake level data is included in the table on page 2 in both datums.
