Meeting was called to order at Daniels Town Hall at 10a by Mike Huber on Saturday October 10th, 2020. There were 19 members in attendance.

Secretary's report was read by Ryan Tjader, Motion was made to approve secretary's report by Katie Tjader. Motion was seconded by Steve Hoffman. Motion carried.

Old Business:

Lake Level update by Deb Luzinski:

Survey results were discussed, and Jerry Fedie presented PowerPoint.

Questions were asked about the beaver dam and what happened to it after the initial top level was taken off.

Ted Fisher is having a zoom meeting on the 13th with the DNR. Craig Duren and Dave Ferris are also joining the meeting. They will discuss water quality, options/possibilities and bring those discussions back to the lake district. Ted also had some brief discussions with an engineer about ideas, but nothing was official.

Craig Duren received a letter in the mail from the DNR on 10-6-20 and Mike Huber read it to the district members. Craig was instructed to have all dam materials and structures removed by 11-1-2020. Mike Huber will join the zoom meeting and present questions on behalf of the district.

Discussions were in place with talks about FEMA vs. DNR jurisdictions and flood zones and who makes those numbers and how they come about them.

Dan Heintz mentioned that there was a similar structure in Cedar Lake in New Richmond that works very well with no issues.

Several people asked if the zoom meeting would be open to the public to listen in on and there was mention that it should be, and a link could be shared if needed.

Deb Luzinski asked if the Mudhen Lake Sportsmans Club could take ownership of the dam if something were to get approved and installed or kept.

Costs with structure were discussed and liabilities of costs to the watershed taxpayers that aren't on the lake along with township residents. Scott Stennes thanked the lake level committee for the work they have put in up to this point. More discussion will continue in March with info from meetings with DNR and county.

Water Monitoring- Scott Stennes stepping down and is willing to train and discuss process with a new volunteer. Steve Hoffman volunteered and accepted the new role.

There were questions asked about the lake health and how to protect it. Questions raised about someone from the county level to attend a meeting and discuss the goods and bads for the lake.



Historical Summary of Mud Hen Lake Lake Level

- 1880-1895 Flooding dam used for log-driving purposes.
- 1934 July 10 Dam Authorization; permit denied unless owner consents.
- 1934 July 10 Memo from W.A. Muegge. Mud Hen Lake Dam (Field Book #875). Benchmarks were established. Notes the dam is earth and rock fill with a timber below the fill. On the date of this survey the water had washed a hole in this dam. There was about 0.5 sec. ft. of flow through this washout. Various lake and dam measurements are included. A picture is also included, but is too blurry to be helpful.
- 1934 July 12 Application by E.I. Bunker and M.A. Clarke for approval of a dam. Commission addressed application/petition for a dam. A temporary dam had been constructed. Carl Forsberg, landowner of the dam site, objected to the dam. The dam was ordered to be removed.
- 1934? Summary sheet for elevation of lake level. Notes "Name of Dam" as Mud Hen Lake; "Stream" as N. Fork Wood Creek. Unclear exactly what date this was taken. Reference points may no longer be present.
- 1941 August 6 Memo from W.A. Muegge. Investigation of June 24, 1941 showed no dam in evidence at the outlet of the lake. A picture is also included, but is too blurry to be helpful.
- 1966 July 27 Petition by lakeshore property owners to take action to raise level of lake. Many signatures.
- 1966 October 13 Letter from Town of Daniels to Public Service Commission presenting petition to raise lake level.
- 1966 November 13 Memo by R.J. Knitter regarding levels of Mud Hen Lake.

 Description of the outlet. There is an outlet stream dam constructed of brush and planks above a timber bridge which holds of head of approximately 1 foot. A reference point was established. The level at the time of inspection appeared to be about the same as held for some time and was approximately normal. Recommends that if a dam application is submitted, it be by the town.
- 1967 January 12 Letter from R.E. Purucker (Chief Engineer, Conservation Department) to Otto Kolander (Town Chairman). Inspection made and benchmark established. Blank application for a dam attached if town wants to submit.
- 1970 August 23 Benchmark established and various levels taken.
- 1974 July 6 Application by Mud Hen Lake Sportsman Club for a dam (spillway).
- 1974 September 21 Letter from Ted Shogquist (President of Mud Hen Lake Sportsman Club). Following up on application for a structure on Mud Hen Lake mailed July 15, 1974. Was supposed to hear back by September 15.
- 1974 December 2 Note from Jack to E. Lawry on DNR form, Bureau of Water Regulation and Zoning. Following up on letter of 9-21-74. Advised that application was not acceptable (needed to be from township).
- 1975 August 2 Benchmark established and various levels taken.
- 1986 September 12 Letter from Scott Hausmann to Jack Donatell regarding lake level hearing request. Notes that they cannot issue a s. 31.02, Stats. because there is no control structure. Would like to see if a control structure is a realistic possibility before proceeding.
- 1989 or 1990 Table with lake levels for 1934, 1970, 1973, 1974, 1987, 1988, 1989, 1990?. *It may be possible to correlate this with other lake level data.*
- 2017 November Communication between Douglas Crane (Land Surveyor) and Frank Dallam (DNR) regarding LOMA request. Recommended checking with Burnett County Zoning for RFE (Regulatory Flood Elevation).

2. Have you had concerns about the lake level over the past years?

Yes-70(83%) No-12(13%) DK-3(4%)

Water too low, 3 years ago too high-June 2020 too low, needs to be higher, mowing the shoreline, never had sand, weeds are worse, have a shoreline we never had, stop taking out beaver dams, was good for a number of years, few past years were very low, when we bought we had 60 feet of dock – now we need 120 feet, very low when other lakes are high, beaver dam too high, just moved here-really don't know, have been occurring over decadesmistake to remove beaver dam, when too high-pushes banks up

3. Has the water level affected your usage of the lake for recreational purposes?

Yes-61(71%) No-20(24%) DK-4(5%)

Too weedy, at end of 95 feet dock the water is 18 inches and stays that way for another 50 feet, fluctuates too much, can't get boat on lift, have to add sections of docking, can't use speed boat-only pontoon, can only swim at beach or middle of the lake, didn't put boat in this year, would like 9 inches higher, can't get boat off lift, what a mess, yes 100%-can't use boat most of summer, pontoon is beached

4. Over the past few years, have you had concern over the health of the lake?

Yes-50(59%) No-25(30%) DK-10(11%)

Too weedy, will be a swamp soon, concerned over invasive plants and zebra mussels, spawning beds have changed, algae bloom that makes lake look rusty, snails, people fertilizing lawns too much, what fish and wildlife will live in muck and bacteria, water temperature has increased, swimmers itch was awful this year, it has all changed, plant foliage taking over, not here long enough to know, land owners putting chemicals on yards and going into the lake-damaging lake

5. Has the water level affected your use of the boat landing?

Yes-54(64%) No- 22(26%) DK-9(10%)

Cars getting stuck in landing, my son won't bring his boat to the lake as the landing is too shallow, don't use boat landing, level makes it hard to get boats in and out of lake, need to dredge landing deeper, evidence of sand erosion along the shoreline, don't have a boat, worse landing I have ever seen

6. Do you think the level of the lake has affected your property value?

Yes-38(45%) No- 29(34%) DK-18(21%)

Taxes keep rising, looks like a swamp, weeds and muck could affect this, rethinking retirement to this lake because of level, lake is turning into a swamp, people want a lake they can easily access, weeds and low level not attractive to people, perspective buyer passed on a lot next door because water was so low, water level and weeds connected to property value, absolutely-who would want to buy a cabin on this mess if they plan to use the lake, property sells well, people using motors to load their boats

7. Would you support a permanent structure to keep the water at an acceptable level?

Yes-65(77%) No-8(9%) DK-12(14%)

- Lake History dates back 100 plus years. 1890's Dam for Logging.
 Activity regarding lake has occurred in almost every decade back to 1934.
- Beaver Dam Totally removed fall 2016. Pictures of removed debris May 13, 2017.
- May 25, 2020 pictures taken. Lake level is going down from spring thaw and rain. No boards or Beaver Dam material to limit outlet flow.
- End of June, 2020, Lake Level very low. Outlet continues to flow even though in 2019, outlet stopped flowing for part of July and August and lake level was higher than June 2020. Bottom Erosion.

Lake Level Timeline

- Sometime around July 4, 2020 weekend, boards installed to retain rain water and limit outlet flow.
- Sometime after August 9, 2020 boards are removed and lake level starts to drop again.
- September 4, 2020 Labor Day Weekend, Lake level down and dry shoreline appearing. Lake level continues to go down.
- Oct. 4, 2020 Lake Boat Landing. Very low, difficult to get boats on trailer and out of lake.






