PAYING YOUR PROPERTY TAXES

BEFORE JAN. 31, 2025

****CASH PAYMENTS BY APPOINTMENT ONLY****

* Mail check payable to Town of West Bend,
6355 County Road Z, West Bend, WI 53095

* Place payment in secure DROP BOX to the left of
front door at the Town Hall.

DO NOT STAPLE/TAPE CHECK TO THE PAYMENT STUB.

* **RECEIPTS:** Enclose a self-addressed, stamped
envelope to receive a mailed receipt or provide
an email address.

* **ONLINE** at landrecords.washcowisco.gov/LandRecords

-Have your tax bill handy

-Enter Municipality from drop down menu(T-13 Town of
West Bend

-Enter Parcel # (numbers after T-13), enter nothing else

-Click " Find Now"

-Click " Pay taxes"/print receipt

Fees: \$1 FOR e-Checks, Debit and credit 2.65% per item

Fees are charged by a third party and not retained by the
Town of West Bend

This is the same payment as utilized by Washington County

* **IN PERSON** at the Town Hall Mondays & Wednesdays
10am – 2pm

AFTER JANUARY 31, PAY WASHINGTON COUNTY:

* Make check payable to Washington County

* Mail to: Washington County Treasurer,
432 E Washington St. West Bend, WI 53095

* You can also pay 2nd installment (payments after
January 31) online on the County website

NOTE ESCROW PAYMENT AMOUNTS

- * Endorse escrow checks properly
- * Include a **separate check** if escrow check is short
- * Expect refunds of \$25 or more within 30 days
of the payment process date

RETURNED/NSF CHECKS

Any check not honored by makers' bank
upon first presentation, will incur a
\$50.00 handling fee, and require
replacement by money order
or cashier's check. Cash or personal
checks will not be acceptable as
replacements.

Dog License Applications

- * Enter ALL information on the application
- * Include a copy of the rabies certificate
- * Include a **SEPARATE CHECK** or
Cash (**DO NOT** include on same check
as your tax payment or w/ leaf & yard
waste permit payment)
If you have multiple dogs, you can
include them all on one check.
- * Include a self-addressed stamped
envelope for dog tag(s) to be sent to
you separate from your tax receipt as
they are processed at different times
and by different departments.

LEAF & YARD WASTE APPLICATION

- * Application is available on website
and in our office
- * Mail in application/Drop in the
dropbox/or bring into our office
- * Include a **separate form of payment**
(cash/check) in the amount of \$5.00
(**DO NOT** include on same check as
your tax payment or w/ dog license)
- * Include a self-addressed stamped
envelope in order for us to send you
the permit via mail
