### **Short-term Rentals**

The Town has partnered with Host Compliance to monitor Short-term Rentals. If you are renting for fewer than 30 days you need to complete the Short-term Rental Application. Operating a Short-term Rental without a license violates the Town of West Bend Municipal Code Chapter 224-4. Additionally, the Town of West Bend imposes an 8% room tax (per Municipal Ordinance 2022-06).
