## **PAYING YOUR PROPERTY TAXES**

**BEFORE JAN. 31, 2026**

### **\*\*CASH PAYMENTS BY APPOINTMENT ONLY\*\***

\* Mail check payable to Town of West Bend,  
6355 County Road Z, West Bend, WI 53095  
(not responsible for payments lost in the mail)

\* Place payment in secure DROP BOX to the left of  
front door at the Town Hall.

**DO NOT STAPLE/TAPE CHECK TO THE PAYMENT STUB.**

\* **RECEIPTS:** Enclose a self-addressed, stamped  
envelope to receive a mailed receipt or provide  
an email address.

### **\*ON-LINE PAYMENTS**

Follow link on Town of West Bend.com under Department,  
Treasurer and Property Taxes

Fees: \$1 FOR e-Checks, Debit and credit 2.65% per item

Fees are charged by a third party and not retained by the Town  
of West Bend

This is the same payment platform as utilized by Washington  
County

\* **IN PERSON** at the Town Hall Mondays & Wednesdays  
10am – 2 pm, December 30<sup>th</sup> 2pm-6pm, December 31<sup>st</sup>  
10am-Noon. Closed December 24<sup>th</sup>.

**AFTER JANUARY 31, PAY WASHINGTON COUNTY:**

\* Make check payable to Washington County

\* Mail to: Washington County Treasurer,  
432 E Washington St. West Bend, WI 53095

\* You can also pay 2<sup>nd</sup> installment (payments after  
January 31) online on the County website

### **NOTE ESCROW PAYMENT AMOUNTS**

\* Endorse escrow checks properly for all parties  
listed on the check

\* Include a **SEPARATE check** if escrow check is short

\* Expect refunds of \$25 or more within 30 days  
of the payment process date

### **\*RETURNED/NSF CHECKS\***

Any check not honored by makers' bank  
upon first presentation, will incur a  
\$50.00 handling fee, and require  
replacement by money order  
or cashier's check. Cash or personal  
checks will not be acceptable as  
replacements.

### **Dog License Applications**

\* All dogs 5 months or older must be licensed  
by 4/1 each year

\* Complete ALL information on  
application & include a copy of the  
rabies certificate

\* Include a **SEPARATE PAYMENT** of  
exact cash or a check for Dog License

\* Include a self-addressed stamped  
envelope to return dog tag(s) via mail

\* In person payments will be accepted  
during tax payment hours

### **LEAF & YARD WASTE APPLICATION**

\* Permit is \$8 and good for 2026 & 2027  
Valid for Town of West Bend residents  
only.

\* Include a **SEPARATE PAYMENT** of  
exact cash or a check for Leaf  
& Yard permit

\* Include a self-addressed stamped  
envelope to return permit via mail

\* In person payments will be accepted  
during office hours all year

All payments for taxes, dogs, & leaf  
& yard must be **SEPARATE**, as they  
they are processed by different  
departments
