WHEREAS, the notice of public hearing regarding the proposed Redevelopment Plan was published in the official newspaper of the Town, twice, in consecutive weeks, as required by law; and

WHEREAS, the Authority has held a public hearing on\_\_\_\_\_\_, 2016 in accordance

WHEREAS, a waiver of notice was received from the owner of the Property; and

WHEREAS, the Town Board and the Authority have found that the Redevelopment Plan is feasible and is in conformity with the Master Plan and zoning, if any, of the Town in accordance with the Act; and

WHEREAS, the Town Board and the Authority have determined that the Property is blighted within the definition provided in the Act; and

WHEREAS, the Authority desires to issue bonds to provide conduit financing for certain projects included in the Project Area on property to be more particularly described by future resolution, including financing a project consisting of \_\_\_\_\_\_ (collectively, the "Project"); and

WHEREAS, the Town and the Authority have undertaken discussions and negotiations relating to the possible development of the Property and the Project Area in the Town (the "Development"); and

HEREAS, the proposed Development is consistent with and in furtherance of the Redevelopment Plan.

#### NOW, THEREFORE, BE IT RESOLVED by the Authority that:

- 1. <u>Findings and Determinations</u>. It has been found and determined and ls hereby declared:
  - (a) that the Development constitutes a "redevelopment project" within the meaning of the Act;
  - (b) that Development in the Project Area is consistent with and in furtherance of the public purposes, plans and objectives set forth in the Redevelopment Plan; and
  - (c) that the Development would act as an inducement for further development in the Project Area, thereby making more likely the accomplishment of the public purpose objectives set forth in the Act.
- 2. <u>Approval of the Redevelopment Plan</u>. The Authority does hereby approve the Redevelopment Plan for the Project Area.
- 3. <u>General Authorizations</u>. The Chairperson and the Executive Director and the appropriate deputies and officials of the Authority, in accordance with their assigned responsibilities are hereby each authorized to execute, deliver, publish, file and record such other documents, instruments, notices and records and to take such other actions as shall be necessary or desirable to accomplish the purposes of this resolution.

In the event that said officers shall be unable by reason of death, disability, absence or vacancy of office to perform in timely fashion any of the duties specified herein (such as the execution of bonds), such duties shall be performed by the officer or official succeeding to such duties in accordance with law and the rules of the Authority.

Any actions taken by the Chairperson and the Executive Director consistent with this resolution are hereby ratified and confirmed.

- 4. Resolution a Contract. No change or alteration of any kind in the provisions of this resolution may be made except as provided herein.
- 5. Conflicting Resolutions, Ordinances, Severability, and Effective Date. All prior Authority resolutions, rules or other actions of the Authority or any parts thereof in conflict with the provisions hereof shall be and the same are hereby rescinded insofar as they may so conflict. In the event that any one or more provisions hereof shall for any reason be held to the illegal or invalid, such illegality or invalidity shall not affect any other provisions hereof. The appropriate officers and agents of the Authority are hereby directed and authorized to do all acts and execute and deliver all documents as may be necessary and convenient to effectuate the actions contemplated by this resolution. The foregoing shall take effect immediately upon adoption and approval in the manner provided by law.
