




# Phelps Area Community Foundation – Northwood Affiliate Group

The Community Foundation offers a charitable fund fee structure that is both cost-effective and supports our best-in-class services to donors and our philanthropic impact in the community.

The Community Foundation's charitable support fees are based on the services offered for each type of fund. These fees, used exclusively to support the Community Foundation's mission, are your investment in promoting charitable giving, connecting donors with causes they care about, and addressing important community issues. Charitable fund fees vary by type of fund, based on the maintenance, paperwork, and services required.

Minimum Opening Balance \$10,000

200% for the first \$250,000

150% for the next \$500,000

1.25% on balance over \$750,000

### **Donor Advised Funds**

Minimum Opening Balance: \$10,000 Minimum Endowment: \$100,000

1.50% for the first \$500,000

1.25% for the next \$1 million

1.00% for the next \$2 million

0.75% for balance over \$3.5 million

### **Designated Funds**

Minimum Opening Balance: \$10,000 Minimum Endowment: \$100,000

1.25% for the first \$1 million

1.00% for the next \$1 million

0.75% for the next \$1 million

0.50% for balance over \$3 million

### Field of Interest Funds

Minimum Opening Balance: \$10,000 Minimum Endowment: \$100,000

2.00% for the first \$250,000

1.50% for the next \$500.000

1.25% on balance over \$750,000

### Nonprofit Agency Funds

Minimum Opening Balance \$10,000 Minimum Endowment: \$100,000

2.00% for the first \$25,000

1.50% for the next \$50,000

1.00% for the next \$75,000

0.50% on the balance over \$150,000

### Scholarship Funds

Minimum Opening Balance: \$5,000 Minimum Endowement \$100.000

2.25% for the first \$25,000

2.00% for the next \$50,000

1.75% for the next \$'75,000

1.50% on balance over \$150.000

### Fiscal Sponsorship Funds

### Minimum Fee:

. Minimum annual fee is \$300, calculated on average daily balance.

### Minimum Grant Size:

- · Community Enhancement Funds, Donor Advised Funds, Designated Funds, Field of Interest Funds are subject to a \$250 grant amount minimum.
- Scholarship Funds are subject to a \$500 grant amount.
- Nonprofit Agency Funds and Fiscal Spor sorship Funds have no minimum grant size.
