Whereas, the Town of Phelps, Vilas County, Wisconsin, (the "Town") pursuant to due authorization issued its \$200,000 Town of Phelps, Vilas County, Wisconsin, Industrial Revenue Bonds, (Northwoods Hospital Association, Incorporated Project), Series 1976, dated February 1, 1976, (the "Bonds") and,

Whereas, Northwoods Hospital Association, Incorporated, as lessee of the Project, (the "Lessee')

has requested that the Town cause the redemption of the Bonds, and,

Whereas, the Lessee has assured the town that it will have available for payment at the time of redemption of the Bonds, funds in a sufficient amount to pay all principal and accrued interest on the Bonds through the date of redemption and any and all costs, charges and fees incurred in the redemption of the Bonds or otherwise the obligation of the Lessee pursuant to the provisions of the Lease by and between the Town and Lessee dated as of February 1, 1976 (the "Lease"), and,

Whereas, the Lessee has informed the Town that all Bondholders (as defined in the Indenture), and Wisconsin Valley Trust Company, as Trustee (the "Trustee") of the Indenture of Trust and Mortgage dated February 1, 1976 (the "Indenture"), will consent to the redemption of the Bonds if authorized by the Town.

Now therefore be it resolved, that the redemption of the Bonds on August 16, 1979, or such other date as is acceptable to the Town Chairman, is hereby authorized and approved and the Town Chairman and Town Clerk are hereby authorized (i) to take any and all actions necessary to cause the redemption of the Bonds, and upon payment by Lessee of the Bonds, accrued interest thereon and all other costs incurred in connection with the Bonds, (ii) to execute and deliver the following documents: (a) a Warranty Deed to the Lessee transferring title to the real estate and improvements described in the Lease; (b) a cancellation of that certain Easement Agreement dated February 1, 1976, by and between the Town and the Lessee; (c) a termination of the Lease; (d) termination's of any and all Uniform Commercial Code financing statements; (e) a Consent and Waiver - Redemption and (iii) to take any and all further action and sign and deliver any and all other documents necessary to effect and complete the redemption of the Bonds and convey the Project (as defined in the Lease) to the Lessee.
