

Resolution #94-1

Whereas, the USDA Forest Service has notified certain people concerning the application of Phelps-Dodge Exploration East, Inc. for permission to prospect an area between Long Lake and Big Sand Lake, and the vicinity adjacent to Secret Lake, both areas within the Town of Phelps,

And whereas, Long and Big Sand Lakes are premium recreational areas because of water purity and the "peace and Quiet" Northwoods atmosphere.

Now therefore, be it resolved on this 10th day of January, 1994 that the Phelps Board of Supervisors opposes the granting of prospecting permits to Phelps-Dodge Exploration East, Inc. or to any other, on the basis of the environmental threat to the area surrounding the proposed sites and the disturbance such prospecting will inflict on adjacent property owners.
