

CHAPTER 25
ORDINANCE TO DESIGNATE HEAVY TRAFFIC ROUTES
THE TOWN OF CENTER, OUTAGAMIE COUNTY, WISCONSIN

The Town Board of the Town of Center, Outagamie County, Wisconsin, has the specific authority under s. 349.17, Wis. stats., and does hereby ordain this ordinance as follows.

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, designates the following town highways as heavy traffic routes:

A. In this ordinance, a “heavy traffic vehicle” means all vehicles not operating completely on pneumatic tires having contact with the road surface and all vehicles or combination of vehicles, other than motor buses, designed or used for transporting property of any nature and having a gross weight of more than 20,000 pounds.

B. The following Town of Center highways are designated as Class B roads and restricted heavy traffic routes and heavy traffic vehicles are prohibited from operating on the following town highways.

- Center Valley Road – West of railroad tracks to Hample Road (2024)
- Twelve Corners Road – From County Road S to Center Valley Road (2024)
- Wege Road – State Hwy 47 to Ballard Road (2025)

C. A designee of the Town Board, by job title or name, shall install and maintain, appropriate heavy traffic restriction signs on the above-described highways before this ordinance can be enforced on each such highway.

D. No person may operate any “heavy traffic vehicle” on the above-noted heavy traffic highways in violation of the above-noted restrictions or prohibitions. Any person who shall violate any of the provisions of this ordinance shall be subject to a municipal civil violation and citation, subject to the following penalties:

<u>Offense Number</u>	<u>Fine</u>
1 st Offense 1-year period	\$100.00
2 nd Offense within 1-year period*	\$200.00
3 rd Offense within 1-year period*	\$300.00
4 th + Offense within 1-year period*	\$500.00

*Determined from the date of the commission of the first offense within 12 months of the offense being cited.

This Ordinance shall take effect and be in force five (5) days after its passage, approval, and become enforceable after the installation of appropriate signs prohibiting operation of heavy traffic vehicles on the above-described highways.

The town clerk shall properly post or publish this ordinance as required under s. [60.80](#), Wis. stats.
