### **Bud Krouse presented with the Gold-Headed Cane on June 10, 2024**

The gold-headed cane tradition began in 1907 when a town-wide celebration honored Alpheus Haynes on his 100th birthday on July 29. The affair, organized by members of the Baptist Church where Haynes was a deacon for 70 years, included a band concert, speeches and a poem. Deacon Haynes was presented with a gold-headed cane inscribed "To the Oldest Person of Middletown Springs, Vt., in Trust". This cane was purchased from a \$90 fund raised for the day's expenses and it was understood that upon Deacon Haynes death the cane would be passed on to the oldest person. The tradition has continued ever since.

### **Future Home of the Middletown Springs Public Library**

Pictured on the cover is the future home of the Middletown Springs Public Library and Community Center. For almost 130 years, this site was the home of the St Anne Catholic Church. The building, as it stands now, was built in 1968 after a fire destroyed the former church building that had stood on the property since 1883.

The Catholic Diocese of Vermont closed the St Anne Parish in 2022 and the building became available for other uses. That fall, the Library Board became interested in the building as a potential space for a larger library. At about the same time, donors stepped forward who shared a similar vision and who were prepared to make a donation to the town for the purchase of the property.

On December 13, 2024, after two years of discussions, the Town purchased the property with donated funds for use as a library and community center.

Transfer Station Hours

**REPORT OF THE AUDITORS FOR FISCAL YEAR 2023 - 2024 (FY24)**

---

The Auditors of the Town of Middletown Springs, Vermont, have audited the financial statements of the town as of and for the year ended June 30, 2024, as listed in the table of contents of the annual town report and available prior to this report. These financial statements are the responsibility of the town officers. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with 24 V.S.A. 1681-1684, which among other things requires that we examine and adjust the accounts of all town officers, and all other persons authorized by law to draw orders on the Town Treasurer.

Our objectives were to (1) validate the correctness of the town accounts, (2) detect fraud or errors in these accounts, and (3) verify the financial condition and results of operations of the town as of and for the year ended June 30, 2024.

To accomplish these objectives, we obtained an understanding of the operation of the town's government, including internal controls over financial transactions. We reviewed and tested various financial operations and responsibilities of the town including bank statements, Treasurer's Report, town trust funds, and board orders.

In addition, based on our observations, we have made recommendations, as needed, for improving the accuracy and reliability of the town's accounting and financial management system.

**Actions Taken FY24:**

- Reviewed the Treasurer's Report, asked questions, and discussed financial information.
- We continued to:
  - Do a monthly reconciliation of bank accounts, using accounting software.
  - Review and sign off on the Selectboard orders.
  - Recommend actions to the Selectboard from the Sullivan, Powers' "letter of deficiencies" (from the external audit).
- Reviewed minutes from Selectboard meetings and budget meetings.
- Made recommendations, in the FY23 report, concerning town trust funds.
- Reviewed the town building project finances and the use of ARPA funds.

Priorities: Town auditors may focus on different aspects of the town finances each year, as part of a rotating review of the overall system. The priority for FY24 was again to monitor town finances related to the town office building project and ARPA funds and will continue into FY25.

**Hours:** In FY24, the two auditors between them worked over 61 hours with over 36 paid hours, and over 25 volunteer hours. One auditor position remained vacant this year. Over the past 12 years, auditors have averaged 140 total hours per year.

**Findings:**

In our opinion, the financial statements we have examined are an accurate representation of the financial position of the Town of Middletown Springs as of June 30, 2024, and the results of its operation for the year then ended. These findings are based on observations and information collected throughout the year, as well as the FY24 Treasurer's Report received on August 27, 2024, and updated on October 3, 2024.

**Based on our observations and testing, we find that:**

- Record keeping and reporting by the Treasurer continues to be accurate, efficient, and clear.
- The Town Clerk's diligence, organization, and efficiency support the stability and safety of the town's financial functions.
- The Delinquent Tax Collector continues to manage a transparent and effective process for collecting delinquent taxes.
- The Selectboard has worked diligently and effectively in managing the town finances.

**Concerns and Recommendations:**

**General Policies and Procedures:**

- As in previous years, we recommend that the Select Board require new town officers to read and sign off on their understanding of town policies. NOTE: This has been recommended annually since FY13.
- As in previous years, we recommend that the Town take action on the observations and recommendations of the Sullivan, Powers external audit. With this in mind, we recommend that the Selectboard work on implementing the financial policies suggested by the Sullivan, Powers external audit. These include:
  - Formalizing, with a policy, the current practice of authorized approval of changes to original financial entries. NOTE: This has been recommended annually since FY20.
  - Updating the credit card policy, and cash receipts policy. The Selectboard has done some work on these as of June 2024.
    - Note: The Selectboard approved an updated purchasing/procurement policy on December 12, 2024.
- We recommend that the Town set up an inventory and replacement schedule for computers and office equipment. NOTE: This has been recommended annually since FY21.
- We recommend that the Town create an approved vendors' list. NOTE: This has been recommended annually since FY21.

**Town Trust Funds:**

- We commend the trustees of the Copeland Cemetery Fund, and of the Copeland Milk Fund for posting meeting agendas and minutes on the town website. We remind the Trustees of Public Monies of the need to do so. We recommend that all town trust funds develop an informational page about their fund for the town website.
- We continue to recommend that the Copeland Milk Fund and the Selectboard seek legal advice about the interpretation of the "covenants and conditions" in the original 1927 document. We note that the trustees are alert to this and have decided to stay with the current practice for the present. NOTE: This has been recommended annually since FY14.

**External Auditing:**

- We continue to support the town's budgeting for the next periodic external audit by setting funds in a restricted account. With the completion of the town office project, and with the start of the library building project, we recommend an external audit be scheduled as the last audit was for FY18.

Starting in March with Town Meeting, where there were three separate elections on one day, town, school and the Presidential primary; then in August we held the State primaries and finally the General Election in November. I am looking forward to 2025 when we have only one scheduled election to manage.

We are continuing to enjoy the new Town Office workspaces and cannot fathom how we ever made things work in the former office. Searching land records and genealogy is so much easier and faster. It's a pleasure to help folks find their ancestors and to be able to show them the volumes of resources we have available and still have room to move around.

We have made great strides in digitizing the land records and are now back to the late 1930's. The next big project we plan to undertake is digitizing and indexing the recorded survey maps. Having those images included with the land records module will make searches even easier. I thank my two assistants, Elizabeth Cooper and Meredith Morgan, for their work to keep those efforts moving forward and for their unwavering support during the past year's elections.

Dog licenses for 2025 are available. All registration fees have increased by \$2. The additional fees go directly to the state to help fund animal welfare programs. All dog or wolf hybrid owners are required to license their dog(s) each year by April 1. After April 1, a late penalty will be applied. I encourage everyone to come in and register their pets before the April 1st deadline.

I'll end with a heartfelt thank you to the community for your support over the past year. It's truly an honor to serve the community of Middletown Springs.

## Town of Middletown Springs DOG LICENSE REPORT 2024

---

Vermont state law requires all dogs or wolf-hybrids be licensed with the Town Clerk each year on or before April 1. All license fees include funds required to be sent to the state rabies and spay and neuter programs.

Licensure requires that all dogs or wolf-hybrids over the age of 3 months have a current rabies vaccination. Certification of vaccination must be on file with or presented to the Town Clerk at the time of registration.

**WHY SHOULD I REGISTER MY DOG?** 1) helps identify your dog if lost, 2) provides proof your dog is protected from rabies in the event your dog is bitten by a rabid animal, but would still need immediate medical attention, 3) if your dog bites an animal or person – which could result in quarantine or possible euthanasia to test for infection, and 4) helps pay for VSNIIP, addressing the population situation in Vermont. Additionally, when someone finds a loose or injured dog, they generally call the Town Office. If I have your information, I can help to reunite you. Please help me, help you by making time to register your dog.

**New for 2025** – All Dog Fees have increased by \$2. New pricing is reflected in the rates below. The increased fees go directly to the State of Vermont to support animal welfare programs.

### Registration Information

**For animals adopted and registered or before April 1, 2025**

Neutered or Spayed - \$11.00 Not Neutered or Spayed - \$15.00

**If registered after April 1, 2025, late fees apply**

Neutered or Spayed - \$13.00 Not Neutered or Spayed - \$19.00

**New animal adoptions after April 1, 2025, have 30 days to register without incurring a late fee.**

**After the 30-day grace period standard late fees will apply.**

**For new animal adoptions after October 1, 2025, fees are as follows (within 30 days of adoption):**

Neutered or Spayed - \$9.00 Not Neutered or Spayed - \$11.00

**Late registration fees after October 1, 2025:**

**In 2024 there were 138 registered dogs in Middletown Springs.**

## 2024

This past year has been a good one for our Town. Our first full year in the new Town Office has gone wonderfully—our public functions are much better accommodated, we're able to keep our records safer and more secure, and we have the space for multiple users and tasks at once. If you haven't been in yet, please stop by; we'd love to show you around.

Our long search for a transfer station operator came to an end in the Fall, when we brought Amanda Magill on board. Amanda has already cleared and reorganized the workspaces and greets all of us with a smile and an offer to assist. We're grateful to have her on board.

The biggest news of the year, of course, was the award of two significant grants for the renovation of the former St. Anne Catholic Church to become the new Public Library, and the gift of that building to the town by anonymous donors. We're grateful to have that recognition of the past work and future prospects of our Library, and to move an important Town project forward without asking for taxpayer construction support at all.

The coming year will bring lots of challenges and opportunities as our Town continues to change. The building we've used for our Town Garage has been purchased by the Middletown Springs Historical Society, and they've asked us to be out by the end of 2026. The work of creating a new highway maintenance and operations garage, back-burnered for so long, now comes to the fore. Bill Reed has deferred his retirement, but we hope to be able to rebuild the team soon so that he can finally let our roads down off his shoulders.

The Vermont Department of Taxes has informed us that it's time for us to conduct a town-wide reappraisal. In addition, it's been five years since our most recent professional audit, and it's soon time to plan for that as well. Both of those projects will help us bring the financial underpinnings of the Town up to date and in line with State and Federal standards.

As always, Middletown Springs is like a duck—peaceful above the waterline and paddling like mad beneath the surface. The Board appreciates the broad support of our neighbors as we conduct the work of the Town, and we look forward to seeing you at a Selectboard meeting, or having you step forward to take on one of the many offices or volunteer opportunities available.

## Town of Middletown Springs REPORT FROM THE BOARD OF LISTERS

---

The Board of Listers are elected officials in Middletown Springs whose primary responsibility is to determine the fair market value of all real property. Real property includes land and structures. The value is converted into an assessment, which is one component in the computation of the property tax bill. The State of Vermont oversees the Board of Listers by comparing assessed values with actual sales.

One challenge that the Listers face is the fact that Middletown Springs does not have any zoning and does not require any permits. Therefore, we ask property owners to notify us if they are doing major renovations, putting on additions or building new structures. We also ask that you notify us of any major depreciation or removal of structures.

State law requires the Board to assess the value as of April 1 of each year. Changes to assessments are mailed to owners in early June and assessments can be grieved by contacting the board with the time frame specified in the change of assessment notice. If any property owner simply wants to see how their property is assessed, the Board will be glad to meet with them and explain the process. It is the goal of the Board to be fair to every property owner across town by assessing all properties equitably and consistently.

We also want to remind property owners to file a Homestead Declaration by April 15, if appropriate.

SWAC represents the towns of Benson, Chittenden, Fair Haven, Middletown Springs, Pawlet, Rutland Town, Shrewsbury, Sudbury, Tinmouth, and West Haven, serving a combined population of approximately 14,000 residents. These towns collaborate to ensure compliance with state laws and mandates, managing solid and hazardous waste in a manner that is both environmentally responsible and cost-effective.

In 2024, SWAC successfully fulfilled the Year Four requirements of the Act 148 / ANR Solid Waste Implementation Plan (SWIP). The SWIP aligns with the State's Material Management Plan (MMP) and provides a comprehensive framework for managing solid and hazardous waste in SWAC towns over a five-year period. As mandated by state regulations, all Vermont towns must participate in a SWIP. The currently approved and adopted SWIP can be reviewed on the SWAC website. Looking ahead to 2025, all Solid Waste Management Entities (SWMEs) will be required to rewrite their SWIPs to meet both extensive existing criteria and new requirements outlined in the updated MMP. SWAC will be seeking input from residents to assist with this important process.

SWAC serves as a liaison to the State of Vermont, advocating for the interests of its member towns on matters such as legislation, rule changes, SWIP requirements, and Product Stewardship initiatives. SWAC is an active member of the Vermont Product Stewardship Council and the Product Stewardship Institute. These organizations have played a key role in advancing Extended Producer Responsibility (EPR) legislation in Vermont. EPR laws hold manufacturers financially accountable for the end-of-life collection and recycling or disposal of their products, significantly reducing disposal and recycling costs for Vermont residents.

Currently, active EPR programs cover the collection of architectural paint, batteries, automobile switches, mercury thermostats, mercury lamps, compact fluorescent bulbs, and electronic waste. Additionally, Vermont's Legislature has passed [Act 58](#), which mandates manufacturers of HHW products establish and fund programs for the collection and disposal of their hazardous products. This law, to be phased in over the coming years, will help to alleviate the financial burden on towns for managing hazardous waste disposal.

**HOUSEHOLD HAZARDOUS WASTE (HHW):** HHW collection is the costliest endeavor undertaken. SWAC contracts with Republic to hold two HHW events. **8.19 tons** of hazardous waste was collected from 139 households. Products included oxidizers, acids, alkalines, reactives, pesticides, aerosols, flammable liquids, ammonia, mercury devices, latex, oil based, and flammable paints, asbestos, and antifreeze. Thank you for participating in SWAC's efforts to properly recycle and dispose of solid and hazardous waste. To keep your communities HHW and solid waste collection costs down, remember to **Repurpose, Reuse, Repair, Refuse, Reduce, and then Recycle**. Consider buying less-toxic products that do not need to be disposed of as hazardous waste. If you do buy a product, use it up for its intended purpose, or give it to a friend, neighbor, or relative to use. Visit the SWAC website (What Do I Do With page) for locations where electronics, paint, batteries, fluorescent bulbs, and waste oil are accepted for **FREE** year-round. No need to wait for the HHW events.

**2025 HW Schedule** - Saturday, **April 26**, Rutland Town Transfer Station, 218 Northwood Park; Saturday, **October 4**, Fair Haven Transfer Station, 175 Fair Haven Avenue. These event times are 8:30 a.m. - 12:30 p.m. These events are free to all SWAC residents. Visit the SWAC website for more information.

**Between Events:** Residents outside the Rutland County Solid Waste District (RCSWD) can purchase a non-district permit to access the Gleason Road transfer station and hazardous waste depot. This permit allows for household hazardous waste drop-off, trash disposal at current rates, and access to recycling drop-off services. Permits can be purchased at the scale house or hazardous waste depot at the transfer station, as well as at the RCSWD offices located at 1 Smith Road, Rutland. Office hours are Monday through Friday, 7:00 a.m. to 3:00 p.m. Permits are not available for purchase on weekends. For more information and current rates, call 802-775-7209.

### Timeline for Vermont's Household Hazardous Waste (HHW) Extended Producer Responsibility (EPR) Law

**January 15, 2024:** ANR will submit a recommended annual registration fee to the Legislature for overseeing the HHW EPR program.

**July 1, 2025:** A single Stewardship Organization (SO) must register with ANR, which will approve only one organization for the initial collection plan.

**July 1, 2025:** The registered SO must submit a single Collection Plan covering all manufacturers to ANR for approval, valid for up to five years. ANR will hold a public comment period during the approval process. For subsequent plans, multiple organizations may register but must collaborate on a unified Collection Plan.

**July 1, 2025:** Landfill disposal of covered household hazardous products is banned.

**6 Months After Plan Approval (Date TBD):** The Collection Plan must be implemented within six months of ANR approval (estimated by March 1, 2026, if approved by October 1, 2025).

Manufacturers not participating in the approved plan will be prohibited from selling covered HHW products in Vermont.

**Reimbursement for SWMEs:** SWMEs will begin receiving reimbursement from the SO around 2027 for costs incurred since program implementation. The stewardship organization will fund program implementation beginning six months after ANR approves the Collection Plan.

THE SERVICE IS FREE TO: RESIDENTS OF THE SWAC TOWNS ONLY - Benson, Chittenden, Fair Haven, **Middletown Springs**, Pawlet, Rutland Town, Shrewsbury, Sudbury, Tinmouth, and West Haven. As a resident of SWAC, you may attend ANY of the events listed above. PROOF OF RESIDENCY MAY BE REQUIRED.

**BETWEEN EVENTS:** Residents of these communities may purchase a non-district permit to utilize the Rutland County Solid Waste District Gleason Road transfer station and hazardous waste depot. The permit allows access to the Gleason Road facility and allows for drop off of HHW and trash disposal at current rates, and access to recycling drop-offs. Permit purchase is available at the scale house or HW depot at the transfer station or at the RCSWD offices, located at 1 Smith Road, Rutland, Monday - Friday (7:00 a.m. - 3:00 p.m.). Weekend permits sales are not available at either location. Telephone 802-775-7209 for additional information and current rates.

**WHAT TO BRING:**

Any substance with labels that say CAUSTIC, TOXIC, CORROSIVE, POISON, FLAMMABLE, DANGER, WARNING, CAUTION, USE IN AN OPEN ENVIRONMENT. **Examples** include: antifreeze, turpentine, stains, varnishes, carburetor cleaner, creosote, drain cleaner, propane tanks, mercury thermostats, oven cleaner, fertilizer, paint strippers, thinners, solvents, gas treatments, old gasoline, engine degreaser, floor, metal, and furnisher polishes, latex and oil based paint, pool chemicals, and pesticides, herbicides, and fungicides (fertilizer without pesticides, herbicides, and fungicides is not a hw - use it for its intended purpose), and batteries (single use or rechargeable - for large batteries, see note below).

**WHAT NOT TO BRING:**

**ELECTRONICS:** Permanent electronics collection locations are available throughout the County to serve Vermont residents. Call toll free at 855-632-9253 or visit <http://www.anr.state.vt.us/dec/e-waste/> to find a collection facility near you. Large businesses should contact the RCSWD at (802-775-7209) to discuss recycling and disposal options.

**SMOKE DETECTORS AND CARBON MONOXIDE DETECTORS** - Intact carbon monoxide detectors and household smoke detectors can be disposed of as trash.

**LARGE BATTERIES** - Most service stations will accept used automobile batteries. Interstate Battery located on 71 River Street, Rutland, also accepts large batteries (automotive batteries or other large batteries).

**FLUORESCENT BULBS** - Residents of Vermont may at no charge to them dispose of mercury-containing lamps at collection sites throughout the state. Residents may take any number of compact fluorescent mercury-containing lamps (cfls) or 10 or fewer mercury-containing lamps that are not compact fluorescent lamps at one time. **LED Lights are not considered hazardous and can be disposed of in the trash.**

**TIRES** are also accepted at the Gleason Road transfer station for a nominal fee and some SWAC transfer stations. Contact your local transfer station for more information.

**VAPING DEVICES** - Check with our local law enforcement officials for options for disposal.

**OTHER INFORMATION**

**CONTAINERS** - Any product brought to the household hazardous waste events (including used motor oil) must be left in the container they are transported in. Materials will not be poured off into larger containers at the events.

**USED WASTE OIL** WILL be accepted at BOTH the Fair Haven and Rutland town transfer station used oil collection areas during the event. TRANSFER STATION ATTENDANTS will be happy to take your used waste oil.

**Used waste oil** is also accepted at many locations throughout the area for **FREE**.

**Trustees Annual Report FY'24**

The Copeland Memorial Cemetery Fund has done well over the previous Fiscal Year '24. We started the year July 1, 2023, with \$173,599.35. Distributed \$10,000.00 to two entities and through Market gains, earned all of that back plus some, ending the year at \$177,175.05! The Copeland Memorial Cemetery Fund was established in 1922 to maintain the Copeland family plot in the Pleasant View Cemetery and to provide for general maintenance of the cemetery. Last year, after several years of inactivity, the Trustees voted to award \$5,000.00 to maintain the Copeland family plot and \$5,000.00 to maintain the Town Cemetery. The Trustees voted last year to move the Fund from Citizens Securities, Inc to the Heritage Family Credit Union in concert with the Town Trusts. The Trustees were unsuccessful in moving the fund management last year and will direct Citizen's Bank to transfer the total Fund to Heritage Family Credit Union in a timely fashion. The Trustees met early in 2025 and will consider awarding funds for FY'25 at its Spring meeting. The Fund Value at the end of December 2024 was \$185,005 all through Market Gains in 2024!



## Library Director's Report 2024

The library remains a hub of activity in the community, welcoming young and old alike who find new and classic books and movies on our shelves to check out and enjoy. Alongside traditional library services, patrons have access to free downloadable audiobooks and e-books and other digital resources, and a growing number of non-traditional items such as snowshoes, activity kits, and knitting needles.

The library provides programs for community members of all ages. A few highlights from this year were the Solar Eclipse Viewing Party, dramatic reading of Poe's *The Raven*, as well as our winter Wishing Tree onto which community members tied their hopes and dreams. Our annual Reading Is Charming Challenge remains a favorite for readers of all ages to participate in. The summer programming continues to be led by Heather Heitkamp Brown, and we recently launched a series of Bedtime Story Times with Claire Ericksen reading to a delighted pajama-clad audience.

We are incredibly excited by the prospect of the new building and the opportunities it will provide for increased service to the community. We are planning and grant writing to support the expansion of services while we continue to provide robust library services.

The Friends of the Library members volunteer regularly to help in the library and with the trustees' fundraising. They also host several of their own fundraising events including the annual plant sale, a perennial favorite. Twenty-five percent of the money they raise goes immediately into their reserve for library expansion and they continue to provide a portion of our collection budget. Their Book Walk continues to delight those walking between the library and the school including students with their teachers, dog walkers, and other community members.

Every year, the Middletown Springs Public Library receives deeply appreciated support from this community: from the town allotment, at trustee fundraisers, by the Friends of the Library, and of course, the time and energy of many people.

**Middletown Spring Public Library Building Project Report**

The Trustees of the Library have been actively exploring ways to expand the library since 2013. The Covid-19 pandemic and the resulting ARPA money that was distributed to states offered an opportunity for our community that had previously not been thought possible. In the summer of 2022, the VT Department of Libraries announced the availability of \$26.2 million in grant funds that would be available to Vermont libraries to address physical building needs. The Library Board of Trustees immediately went to work assessing our options. No good scenario revealed itself until the St Anne Church building became available in the fall of 2022.

Our first step was to assess the feasibility of using the building for a library and community space. The Library Board worked diligently in collaboration with the Selectboard through early 2023 to assess the building. Once it was determined that renovations could make it suitable for the desired purpose, we went to work gathering information to make a compelling grant application to the U.S. Treasury Capital Projects Fund for Libraries (CPF) through the VT Department of Libraries.

In March 2024, the town submitted a \$1.29 million grant application to the VT Department of Libraries for CPF grant funds. In June 2024, we learned that we were awarded the whole \$1.29 million and a 14% contingency available should we need it. While we waited for news of the CPF grant award, another grant through the state Municipal Energy Resiliency Program (MERP) became available. MERP offered municipalities grant money to improve the energy efficiency of their municipal buildings. In May 2024, we applied for approximately \$500K from that grant. In October 2024, we learned we had been awarded \$225K for the library and community center project.

In the fall of 2022, when the former St Anne Church building became available for other uses, the Library Board of Trustees entered into negotiations with the Diocese. Shortly after this, some donors stepped forward and communicated their shared vision of the building repurposed as a library and community space. They offered a generous anonymous donation to purchase the building for that purpose. The process of completing the purchase was delayed for more than a year as the Catholic Diocese of Vermont had to find, ordain, and install a new bishop. On December 13, 2024, after two years of discussions and delays, the Town purchased the building, with donated funds, for use as a library and community center.

Once the purchase was finalized, the Library Board got started on the preliminary work for the project, those efforts have included: removing the underground oil storage tank, installing a temporary tank inside, assessing and planning for the removal of any environmental hazards and beginning to plan for a volunteer demolition crew to begin work in the spring, once architectural drawings are completed. On January 4, 2025, we hosted an open house in the space and had an excellent turnout. We heard a lot of exciting ideas and shared our enthusiasm for the new future use of the property, a property that has been an anchor in this community for close to 150 years.

Throughout the rest of 2025 and into early 2026 you will see lots happening at the new site. Look for updates on our website, on Front Porch Forum, in our meeting minutes and in your mailbox. We anticipate hosting the community at another open house in the Fall of 2026 to celebrate our grand opening!

**A Year In Review 2024**

Middletown Springs Volunteer Fire Department responded to calls consisting of motor vehicle accidents, structure fires, carbon monoxide alarms, fire alarm activations, furnace malfunctions, EMS assists, illegal burns, calls for smoke in the area, chimney fires, grass and brush fires, power poles down, trees and wires down, and a hazardous materials response. MSVFD responded, as a mutual aid department, for Poultney Volunteer Fire Department. The mutual aid calls were for structure fires and chimney fires.

Along with volunteers responding to emergency calls, these same volunteers spend many hours participating in trainings. The hundreds of training hours are on top of emergency response calls. Our members are dedicated and deserve appreciation for the time they put into our community. Training takes place in several locations throughout the year. MSVFD works closely with other local departments. As rural volunteer fire departments, we rely on each other when responding to calls.

Assistant Chief, Deryk Knipes attended the International Ice Water Rescue Instructor Academy. He spent 5 days in Portland, Maine doing Ice Water Rescue and obtained his certification as a technician and an instructor. Six of our other members are certified as technicians, which establishes MSVFD as a certified Ice Water Rescue Team in our region. The rest of the MSVFD membership is in the process of obtaining their Ice Water Rescue Technician certifications. We are proud to offer this service to our community.

On August 23, 2024, the Middletown Springs Volunteer Fire Department (VT) was notified by the Department of Homeland Security that their Fiscal Year (FY) 2023 Assistance to Firefighters Grant (AFG) funding application had been approved for \$59,357.14. Total Project \$62,325.00. The funds were specific to purchasing new fire hose for each apparatus. Thank you to the Department of Homeland Security FEMA and our Federal and State Representatives and Legislature. This grant was awarded with the help of our contracted grant writer. This is a huge award and accomplishment for MSVFD and the taxpayers.

MSVFD currently has five apparatus in operation. The tanker holds 1250 gallons of water and serves a specific purpose for fires of any nature. The ladder and engine/rescues serve multiple purposes, such as, housing equipment for motor vehicle accidents (including "jaws of life" on all three), medical assists (including a defibrillator), priority one echoes, shutting down roadways, structure fires, accessing roofs, accessing chimneys, accessing trees, and water supply for fires. MSVFD is proud to say they have the quickest, safest, highest ladder in the surrounding area. The attack truck is also a multi-purpose apparatus. Its primary use is for grass and brush fires, but it is capable of being a primary pumper, on a structure fire. It is equipped with a winch for recoveries of off-road motor vehicles, ATVs, and downed trees/debris. The MSVFD takes great pride in our apparatus. All apparatus are in excellent shape and look new. All apparatus have a zero-dollar balance. New replacements for these vehicles would total approximately \$4,500,000.

Middletown Springs Volunteer Fire Department held fundraisers in 2024. The Memorial Day concession stand has become more of a community event instead of a fundraiser. The Hunter's Raffle took place in October, and a bus trip to New York City was held in December. Although Halloween at the Firehouse is not a fundraiser, it is a favorite community event. We had a record number of trick-or-treaters this year!

The fire department took part in a Fire Safety Day at the Middletown Springs Elementary School. Students of all ages learned the importance of knowing their address, landmarks, when to call 911, escape routes, knowing two ways out, looking for exit signs, looking for AED signs, "firefighter call out" responses, and fire and smoke behavior. Grades 4 through 6 participated in using a fire extinguisher. A mock fire was created, and students were able to go through the PASS steps while engaging a fire extinguisher.

The MSVFD Board of Trustees, a non-profit organization, which oversees financials, fundraising, and communication for the fire department, has decided to increase the operating budget for Fiscal Year 2026, as our expenses have increased. The total operating budget request is \$86,000. This is an increase of \$4,115, it is the first increase in our budget request since 2019. This small amount will help with increasing costs of PPE, insurances, fuel, and utilities.

MSVFD membership meets every Tuesday at 6:30pm, the MSVFD Board of Trustees meets every second Wednesday of the month. We welcome ALL community members to stop by with questions, concerns, information, and volunteer interests. We will continue to provide for our community in the coming year. Thank you for your continued support, and thank you to all our MSVFD members, which are 100% volunteer!

---

The main focus of the Middletown Springs Planning Commission is to review and update the town plan which is currently updated every seven years per Vermont Statute. The plan is due for updating by early 2025 with resident input. The Planning Commission arranged with the Rutland Regional Planning Commission to develop the energy plan section for the updated Town Plan in a way that gives the town optimum standing for input on any proposed energy projects. The Commission secured grant funding to cover the cost of that effort.

In late 2024, the Commission created and circulated a town-wide survey to gather information from residents. The Commission is currently incorporating survey responses into the draft of the revised plan and is receiving support from the Regional Planning Commission as we finalize the draft document.

In addition, we offer our services to the Selectboard and the Conservation Commission for any planning related issues and opportunities. The Planning Commission has been involved in past projects, such as the Middletown Springs Creative Economy grant and has participated in the Real Rutland Campaign.

## Town of Middletown Springs REPORT OF THE CONSERVATION COMMISSION

---

The Middletown Springs Conservation Commission (MSCC) is a five-person board first established in 2000 to steward the town's 14-acre Sullivan Educational Woods, located off of Fitzgerald Road. MSCC has worked with our community to learn about and sustain the natural resources of our town. Conservation Commission initiatives include stewardship of Sullivan Educational Woods, educational programs and nature walks for the community, monitoring and controlling invasive species, contributing to town planning efforts, coordinating Green Up Day, and monitoring and assessing the town's rivers, wildlife, wetlands, and upland natural communities.

### **Green Up Vermont Day**

The 2024 Green Up Vermont Day took place on Saturday, May 4. The 6- and 7-year-old Girl Scouts of Troop 63133 welcomed neighbors with treats and gave hands-on demonstrations of how to build a green bean teepee. Roughly 33 individuals and families turned out to help clear close to 24 miles of the town's roadsides of trash and keep our town looking cared for. Approximately 25 bags of trash were collected and disposed of.

### **Sullivan Educational Woods**

After the original informational kiosk at the entrance to the woods collapsed due to decay and wind, the Commission collaborated with Tim Parent and students at Mill River Union High School to replace it. The students and town volunteers installed the brand-new kiosk this spring! The kiosk project was made possible through a grant secured by the Commission from the Association of Vermont Conservation Commissions (AVCC). The Commission secured an additional grant from AVCC this year to enable the Mill River students to create a wooden footbridge where the forest loop trail crosses a perennial stream. The MSCC created a slideshow of these projects and presented it to AVCC.

Commission members and volunteers did trail clean-up to remove debris and several downed trees resulting from a series of storms. Encroaching vegetation and large woody debris was cleared near the old meeting circle and kiosk site to make the area more user-friendly. Special thanks to Richard Kniffin and his chainsaw, as well as the Carr, Weatherhogg and Doyle-Graves families for their frequent efforts on behalf of the forest.

CC members held a community woods walk with several families with young children. Children collected and examined different kinds of leaves and enjoyed a funny and imaginative story read by Elizabeth Cooper.

### **Membership**

The commission recognizes and thanks Elizabeth Cooper for her commitment and leadership as she ends her official tenure with the group. We are also actively seeking three additional Commission members.




In November 2024 the Historical Society Board of Trustees fulfilled a decades-old MSHS dream of acquiring a central place for storing and displaying the A.W. Gray Horsepower equipment collection with the purchase of the c.1800 Middletown Baptist church building, opposite the MSHS Adams House on North Street. Development of the building will begin after the Town Garage relocates to a new site.

Middletown Springs Historical Society Trustees produced two popular annual events in 2024: the Maple Festival in March, and the Strawberry Festival in June. Opening at the summer event was a comprehensive exhibit at the museum about the life of Dana Carpenter "A Man for all Seasons", which remains up through March 2025.

The exhibit, curated by Collections Manager Mary Lou Willits using objects from the MSHS museum collection as well as articles on loan from Emmett Francois, focuses on Carpenter's concurrent careers as Middletown Springs pharmacist, town photographer, and renowned Vermont botanist whose 6000-specimen lifetime collection of Vermont plants now resides at the Pringle Herbarium at the University of Vermont. Carpenter also served the town in various capacities including Representative to the Vermont Legislature.

A project was completed this fall at the Adams House to capture and remove radon and moisture from the building basement. The addition of a vapor barrier and venting system was paid for by a matching grant from Preservation Trust of Vermont.

During 2024 MSHS worked with videographers Sally Ferguson and David Caras of Granville, N.Y. to design and produce the Video History Project, recording and editing the recollections of Middletown Springs historian and President of MSHS, David Wright. Over 50 hours of recordings have been indexed and archived, and three of the video interviews will soon be available on the MSHS YouTube channel.

The new Historical Society website, developed by Ferguson-Caras LLC, working with a MSHS board committee, continues to grow and now includes a YouTube channel. The new site features town history articles, photo galleries, and an archive of MSHS newsletters. The website's new structure allows for easier updating and is fully accessible to users with physical, visual, and hearing deficits. Visit now at [mshsvt.org](http://mshsvt.org).

The Historical Society has over 200 members including 69 town residents, 14 second-home owners, and about 150 others throughout the country. Membership is open to all. Members receive the MSHS newsletter as well as discounted facilities rentals for family gatherings.

### Southwestern Vermont Council on Aging

Southwestern Vermont Council on Aging (SVCOA) helped provide 1,706 meals that were delivered to the homes of 10 older residents in your community. This service is often called "Meals on Wheels". In addition, 9 older Middletown Springs residents came together at a luncheon site in your area to enjoy a nutritious meal and the company of others; 228 meals were provided. Additionally, SVCOA provided 13.25 hours of one-on-one nutrition support, including nutrition assessments and resource connections and referrals, to 26 residents of Middletown Springs.

SVCOA staff helped 18 residents in your community for a total of 165.25 hours. Case managers meet with an elder privately and assess the elder's situation. They work with the elder to identify needs and possible services available to address those needs. Case managers also help elders connect with in-home assistance programs.

Other services and supports include: "Senior HelpLine"; Medicare and health benefit counseling; legal service assistance; Nutrition education and counseling services; Outreach services for older Vermonters dealing with mental health issues; Companion support for frail, homebound elders; Money Management; Transportation assistance and Caregiver support.

For over 45 years, the Vermont Center for Independent Living (VCIL) has been teaching people with disabilities and the Deaf how to gain more control over their lives and how to access tools and services to live more independently. VCIL employees (85% of whom have a disability) conduct public education, outreach, individual advocacy and systems change advocacy to help promote the full inclusion of people with disabilities into community life. Annual support from over 140 cities and towns across the State helps VCIL assist Vermonters with disabilities achieve dignified and self-determined lives.

In FY24, VCIL responded to thousands of requests from individuals, agencies and community groups for information, referral and assistance and program services for individuals living with a disability. Services include interpreter referral services for sign language, spoken English and CART services for assignments in medical, legal, mental health, employment, educational, civil and recreational settings, as well as Peer Advocate Counselors and services.

## Rural Fire Protection Program

The Rural Fire Protection (RFP) program helps local fire departments identify appropriate sites for dry hydrants and other rural water supply systems, design installations, and finds financial support to support the costs of construction. During the 27+ years of the program, almost 1,242 grants totaling over \$2.9 million have been provided to Vermont towns for installation of new rural fire protection systems, as well as for replacements and repairs. In the past year, RFP provided grants to support the construction and repair of 13 rural fire protection projects throughout Vermont, as well as covering site assessments, project design and program oversight.

Two hundred thirty five Vermont communities have benefitted from the Rural Fire Protection program. Our goal is to extend this support to all Vermont towns and continue to assist local fire departments in reducing the risk of injury, loss of life, and damage to property and natural resources, thereby improving the safety and welfare of Vermont communities. In FY24, RFP received over \$9,150 in town appropriations from over 90 towns, support which is critical to fully funding RFP programming.

## Poultney-Mettowee Natural Resources Conservation District

Poultney-Mettowee Natural Resource Conservation District (PMNRCD) is a non-profit organization with a mission to develop programs that will facilitate the conservation of soil and clean water. The Poultney-Mettowee watershed consists of all the lands that drain to the Poultney or Mettowee Rivers and their tributaries. Both the Poultney and Mettowee Rivers drain to South Lake Champlain. PMNRCD has been providing environmental support, education, and outreach to the 14 towns in the district watershed for over 70 years.

PMNRCD is working with towns in various ways:

- **Stormwater Management** - implementing 'green stormwater' projects
- **Waterways** - projects focused along waterways to restore habitat and improve water quality
- **Agricultural Programs** - working with farmers on nutrient management and water quality guidance
- **Champlain Valley Native Plant Restoration Nursery** - PMNRCD collaborates with Nursery and area residents to make improvements to water quality, create habitat, and to control erosion
- **Clean Water Service Provider** - partnering with the Rutland Regional Planning Commission to provide funding and technical assistance to local towns as the local CWSP

NeighborWorks of Western Vermont, a nonprofit, is a one-stop-shop providing all the answers and support homebuyer and owners need.

While it was once again a challenging year for so many, we are pleased to report that with continued generous funding from our incredible partners, the state of Vermont, and Middletown Springs, we were once again able to assist many Vermonters with affordable housing services including homebuyer education and counseling, down payment assistance, home repair and energy loans and grants, home energy audits and energy efficiency projects, and housing improvement assistance to landlords. Below is a summary of the specific services we were able to provide throughout our service area.

In FY 2024, our services comprised of:

- 137 Low-cost, Comprehensive HEAT Squad Energy Audits and 135 Home Energy Improvement Projects were completed for which homeowners received a rebate from Efficiency Vermont.
- 44 Energy Loans, totaling \$801,164, helped homeowners make energy improvements to their home.
- 59 rental units rehabilitated.
- 8 Down Payment Assistance Loans totaling \$287,175 were made to assist homebuyers make it over the 20% down payment barrier.
- 8 Home Repair Loans totaling \$80,154 and 26 Home Repair Grant totaling \$119,961 were made to homeowners to make health and safety upgrades.
- 71 families attended Homebuyer Education and of those 19 became homeowners.
- 82 households participated in homeownership or financial coaching.
- 4 grants totaling \$132,050 were made to homebuyers who utilized Vermont's Share Equity Program.

### ARC (Advocacy-Resources-Community)

The mission of ARC is to advocate for the right of individuals with developmental disabilities (DD) and their families to be regarded as valued citizens with the same entitlements as non disabled individuals, including the right to lifelong opportunities for personal growth and full participation in the community.

Programs in 2024 included:

- **Representative Payee Program:** ARC serves about 50 individuals living with Developmental intellectual Disabilities by managing each client's individual SS income and processing payments of their financial obligations timely. The Rep. Payee works with other agencies and client's case managers to direct our members toward receiving appropriate services.
- **Self-Advocates (SABE-R) and AKtion Club:** The Self Advocates Becoming Empowered - Rutland trained and practiced Disability Acceptance presentations about what it is like to live in Rutland county as and adult living with developmental disabilities to various organizations. The Aktion Club (a Kiwanis member group) created a new fundraiser, 8-Bean soup in a jar, we expanded our "jar" series to include 'fairy jars'. A self-sponsored Carwash and Bake Sale allowed them to donate to a family of the Boys and Girls Club.
- **Social Events/Great Outdoor Experiences:** These events provide a safe and healthy environment for individuals with developmental disabilities that builds a circle of support, family and community while practicing social skills, and getting physical exercise.

**Vermont Association for the Blind and Visually Impaired**

For many years, the town of Middletown Springs has supported our mission to help Vermonters with visual impairments to be more independent, cultivate adaptive skills, and improve their quality of life. With your help, the Vermont Association for the Blind and Visually Impaired (VABVI) has completed another successful year. Thank you for your ongoing support!

An estimated 14,000 Vermonters are currently blind or visually impaired. As the "Baby Boomer" generation ages, this number is expected to increase to at least 25,000 by 2030. We anticipate that the increase in demand for our services will continue well into the future. Our neighbors, family and friends are among those who may be coping with vision loss.

It costs VABVI approximately \$1,000 to provide one year of service to each adult client. In Fiscal Year 2024, the agency provided services to a total of 1,048 Vermont residents. This total includes 4 adults in Middletown Springs and 110 adults and 23 students in Rutland County.

We provide a safe comfortable environment for the forensic quality and child appropriate interviews, training for professionals and collateral referral services for victims and their non-offending family members. In calendar year 2024, The Child First Advocacy Center served 121 clients and 118 of their family members. We were able to provide direct wrap around services and support to one (1) Middletown Springs family as they began their recovery from the effects of trauma. In addition, we continue to provide community awareness and education at no cost, in an effort to provide adults with the ability to recognize, react and respond appropriately to child sexual abuse and increase each school district's ability to complete the legislatively mandated ACT 1 initiative also known as Child Sexual Abuse Awareness training for Educators, Community Members and Students grades K-12.

**Rutland County Restorative Justice Center**

---

Rutland County Court Diversion and Restorative Justice Center (RCRJC) is a 501(c)(3) non-profit agency that strives to make Rutland County a healthier and safer community for all residents. Our mission is to engage community members in responding to the needs of crime victims, the community and those who violate the law, holding the latter accountable in a manner that promotes responsible and restorative behavior. Our programming is designed for a range of individuals, such as at-risk and truant youth and those with mental health and substance use treatment needs. We focus on fostering accountability, repairing the harm caused by crime, skills development, and connection to treatment and education.

In FY24, the RCRJC’s eight programs served 683 participants who chose community support and accountability over the traditional criminal justice system, helping: 131 people connect with volunteers to address the harm they caused in the community through restorative panels; 35 youth complete the Youth Assessment and Screening Instrument to determine risks and needs of the youth; 95 adjudicated, at-risk, or truant youth work to improve school/appointment attendance, therapeutic treatment engagement, one-to-one support and community-based visits, case plan and court hearing support, coping skills, time management, and community and family connections; 97 youth aged 16-20 participate and complete the Youth Substance Awareness Safety Program that identifies and educates youth about dangers of substances for which they received varying violations; 72 people seek substance misuse treatment and 67 people work towards reduced fines, violation issues, and reinstatement of their driver’s licenses.

Our agency has served Rutland County for decades and we look forward to continuing to meet the needs of our community members for many years to come.

### Vermont Farmers Food Center

---

The Vermont Farmers Food Center (VFFC), located in Rutland at 251 West St., began as a grassroots, volunteer-led project, and is spearheading the rebuilding of infrastructure necessary for agriculture to serve as a regional economic engine through the development of 2.93 acres of industrially zoned land with four existing buildings in the heart of downtown Rutland.

VFFC increases access and availability of locally produced food in the Rutland Region through education, expanding markets and market access, and aggregation and distribution of locally produced and value-added agricultural products. From January 2021 until November 2024, our main facility had been closed and unable to be used for programming and tenant rental income. Thankfully, the Winter Farmers Market has returned to Farmers Hall this November. Through all of the challenges, VFFC's programs have continued!

VFFC operates several programs:

- **Farmacy Project** is a "food as medicine" program that provides fresh produce from local farmers for at risk individuals and families with health issues who have been prescribed 15 weeks of fresh, local produce.
- **Farm Based Experiential Learning (FABEL)** provides an experience of learning substantive life skills on the farm and in the garden through hands on engagement.
- **Everyone Eats** was a food relief program that leveraged CARES Act Funds to engage local restaurants in making to-go meals for anyone who has been impacted by the COVID-19 crisis due to unemployment, underemployment, homelessness, or other challenges. Over 2900 meals were delivered weekly at VFFC and working with distribution partners throughout the county.
- When Everyone Eats ended, we started our own version of the program **Rutland County Eats** and have been distributing 200 meals each week through this program.
- In response to those affected by the floods this summer, **Vermont Emergency Eats** ran from August through November of 2023 and we were a distribution sight for this program.
- **The Online Market** began in April 2020 as a way for farmers to continue to have a way to get their products to consumers when the farmers markets were not able to operate. It has continued to offer a weekly safe and convenient curbside pickup.

VFFC works with local farmers/producers, including in Middletown Springs, who participate in the Online Market and Everyone Eats programs and serves members of our community through those programs.

### The Mentor Connector

---

Each year, The Mentor Connector guides more than 150 vulnerable youth and young adults in southwestern Vermont through life changing friendships to build goals, character, and skills to be successful in life. Since opening our doors in 2004, we have mentored more than 1,000 young people, collaborated with hundreds of local businesses and organizations to support youth, and have been highlighted nationally as a model program.

Virtually all program youth are living in poverty, 8 out of 10 suffer from family instability, and most are affected by violence and/or addiction. Without additional resources most of these youth would end up continuing the cycle of addiction and poverty they are living in. However, the narrative changes when matched with a mentor.

Our highly skilled mentors use fun, teachable moments to transform each youth's life narrative. Every day we see the transformation from instability to hope. Each one-on-one mentor match uses an individualized program to enhance social-emotional, academic, and workforce development skills. This combination establishes goals and builds a network of support around each youth that remains a stable part of the youth's life.

Moderator, Kimberly Bushnell called the meeting to order at 6:30pm. Kimberly welcomed everyone to Town Informational Meeting 2024. This is our first hybrid town meeting with folks joining on Zoom as well as in the room. Kimberly thanked Kevin Eaton for volunteering to monitor Zoom for us. Kimberly then went through instructions for speaking and asking questions during the meeting.

She outlined how articles 12 to 36, which are local organization appropriations, can be bundled as one item at the end of the session, questions on any of these articles will be entertained at that time.

Kimberly led the room in the Pledge of Allegiance.

She then introduced State Representative (and town Selectboard member) Robin Chesnut-Tangerman who came to review the news from Montpelier. Housing is the biggest issue facing Vermont today as a whole. This issue threads through all the other important issues Vermont is facing. Housing stock is low and expensive not only in our area but also across the state. The legislature is working on this issue and trying to find creative solutions to address the problems within the state's capacity to fund any projects. Robin wished he had a more cheerful report but this problem is serious. He then asked for questions from the floor.

Jon Mathewson asked about the neonicotinoids pesticide bill which would ban these pesticides that are harmful to pollinators.

Robin stated that the bill is currently in process, expects house to pass it, not sure about what will happen when it goes to the Senate.

No other questions.

Robin thanked everyone for attending and was encouraged to see such a good turnout.

Terry Redfield, on behalf of the Selectboard, thanked Robin for his service to the town as a selectboard member as well as the state representative.

Kimberly read the warning introduction as presented, then introduced Herb Childress, chair of the Selectboard to give a few opening remarks before we move on to the articles up for discussion.

Herb introduced the selectboard, Herb Childress, Patty Kenyon, Terry Redfield, Peter Stevensen and Robin Chesnut-Tangerman. Herb thanked both Peter and Robin for their service, acknowledging that they have chosen not to run this year.

Herb then reviewed the tasks of voting tomorrow, we will be voting town officers, town ballot items, school ballot items, and your choice of ballots for the Presidential Primary, so be sure to give yourself enough time to review the ballots and cast your votes.

Herb thanked the Town Clerk, Patty Kenyon, also a selectboard member, for organizing a very complex election ahead of us.

Kimberly then began to read the warning articles.

1. To elect Town Officers as provided by Vermont Law.

No questions.

2. Shall the voters of the Town of Middletown Springs accept the report prepared by the Town Auditors?

Juanita Burch-Clay – Town Auditor thanked Sarah Grimm who has been an auditor for seven years for her past service. Sarah has been attending selectboard meetings and reviewing board orders regularly. Sarah has chosen not to run again this year. Nita encouraged folks to step up and fill the open auditor position. She reviewed the job of a town auditor to try to encourage and pointed to pages 12 and 13 of the town report to give folks a sense of the duties of an auditor. If you are interested in being a town auditor, please reach out to Nita directly.

Nita then reviewed the auditor's general observations on the financial health of the town. The auditors believe that the current town officers are doing a good job keeping the town's finances in good health. The town has made a lot of progress over the last ten years toward keeping a good financial house. One example is the successful completion of the new Town Office.

No questions posed to the auditors.

3. Shall the voters of the Town of Middletown Springs appropriate **\$419,495** for the **general operation** of the town, the sum of **\$339,995** to be raised by taxes on the 2024 Grand List of the Town of Middletown Springs for the fiscal year of July 1, 2024 through June 30, 2025?

Pat Hemenway commented that she thought that the proposed budget was really tight and well thought out. But she did not notice any money in the budget for maintenance of the new building.

Herb referred Pat to page 33 (the town budget) under the Town Office category there is \$12,500 for maintenance of the town office. This number includes maintenance and utilities to run the office.

No further questions.

4. Shall the voters of the Town of Middletown Springs appropriate **\$580,120** for **the care and maintenance of highways**, the sum of **\$424,620** to be raised by taxes on the 2024 Grand List of the Town of Middletown Springs for the fiscal year of July 1, 2024 through June 30, 2025?

No questions on the highway budget.

5. Shall the voters of the Town of Middletown Springs authorize the Select Board to fund the **Municipal Tax Stabilization Reserve Fund** with any surplus **up to \$5,000** from the current fiscal year General Fund budget, to be used to reduce unanticipated tax increases due to general fund cost overruns?

Melissa Chesnut-Tangerman asked the Selectboard to explain this article.

Patty Kenyon reviewed the article's intended purpose which is to save money left at the end of one fiscal year to be used in another fiscal year when needed. Basically, a rainy day fund used to stabilize taxes when the town faces unexpected cost overruns at the end of a fiscal year. small amount of any surplus funds generated to be used in the future if we face a deficit.

No further questions.

6. Shall the voters of the Town of Middletown Springs authorize the Select Board to fund the **Reserve Fund for Town Municipal Facilities** with **up to \$50,000** of any non-allocated General Fund surplus from the current fiscal year, and further allocate any surplus still remaining to be used to reduce taxes?

Sally Achey asked the Selectboard to explain the purpose of this specific fund in relation to the fund that was set up to help fund the town office building.

Patty explained that initially the Municipal Facilities fund was established to be more generalized, because the town had many facilities needs and the Selectboard at that time wanted to make sure the money could be used for any municipal project. Later on when the Selectboard began to add general surpluses to the fund, the treasurer accounted for those surpluses separately from the money that was dedicated for the new town office. Continuing to fund this reserve gives the Selectboard some funds to work with in the early stages of a project.

Sally asked, if this article doesn't pass, what would happen with a surplus?

Patty responded that if this didn't pass, more than likely any surplus would be used to reduce taxes.

No further questions.

7. Shall the voters of the Town of Middletown Springs authorize the Select Board to establish a **Reserve Fund for Memorial Day Commemoration**, to be funded with previously unused Parade funds plus any future voter allocations and external funds raised to support the annual parade and ceremony on the Green?

Patty Kenyon explained the intention of this reserve fund. Since the Grange disbanded and town volunteers took over the organization and funding of the parade, they asked the town to hold and disburse their accumulated funds. This money has been kept in a pass through account. The proper way to deal with that money is to have a dedicated account for it, this article if passed will create that account. There is no taxpayer cost for this article.

No further questions.

8. Shall the voters of the Town of Middletown Springs authorize the Select Board to establish a **Reserve Fund for Highway Expenditures**, to be funded with existing and future highway surplus funds?

Herb explained the intent to establish a reserve fund for highway expenditures. This fund provides a dedicated accounting container specific to surplus highway funds.

Sally Achey asked how does this fund differ from the current highway surplus fund?

Herb answered that this fund could be used for vehicles equipment or supplies.

Sarah Grimm asked does this surplus have a limit like the other reserve funds do?

Herb answered not currently. In the future the board might see a need to impose a limit.

Carl Haynes asked about the Highway Surplus fund listed which currently has \$99,000 in it and the fund that has \$124,000 in it.

Patty answered that currently the highway surplus fund is not a town highway reserve fund. General year end highway surpluses, as outlined by the state, have specific rules for spending those funds. In general, they can only be used for the budgetary purposes they were initially budgeted for. If we create this town reserve fund and stipulate that highway surpluses go into that fund at the end of the year, we can then use those fund for any highway expenditures we have instead of only the highway line items they were originally gleaned from.

No further questions.

9. *(An Advisory Vote)* Shall the Voters of the Town of Middletown Springs authorize the Selectboard to include existing allocations to non-profit agencies within the Town General Government Budget, with individual ballot items only for new or increased requests?

Herb explained that this is an advisory vote, we'd like to know the sense of the community. There is a cost to having all of these individual ballot items listed and voted on separately. So, this is asking, if something has been approved over and over should we just write it into the budget?

Jon Mathewson stated that he was under the impression that the reason we voted on these separately was by court order.

Patty answered that she learned that the state allows any town to build these items into the budget. In the early 2000's the town had an advisory vote to see if folks wanted to see all these items on the ballot. That vote was in the affirmative. After that time these items were added to the warning individually. The lawsuit came from a resident who didn't like the wording of the articles. The court then determined the proper wording for these articles should they appear on the ballot. That court order did not take away the Selectboard's ability to decide whether or not they should appear on the ballot.

To include these 20 odd items on the ballot each year costs \$40 per article just to program the tabulator. There is also the increased cost of paper both for ballots and the town report and time to put together such a big warning.

Tracy Weatherhogg asked would this change the process for organizations asking for money?

Patty answered that every organization would still need to request money each year, articles would only be voted on if a previously approved organization asked for more money or a new organization asked for money. Everything else would be the same.

Jim Graves asked what if the Selectboard decided to stop funding an organization?

Patty answered that in the spirit of the article wording the Selectboard wouldn't have the authority to make that decision.

No further questions.

10. Shall the Town of Middletown Springs deem necessary and appropriate **\$81,885** for the **Middletown Springs Volunteer Fire Department** determining that the program serves the residents of the town with fire protection and emergency response services?

No questions.

11. Shall the voters of the Town of Middletown Springs deem necessary and appropriate **\$1,500** for the support and general operation of the **Pleasant View Cemetery Association** determining that it provides preservation and maintenance of the cemetery?

Juanita Burch-Clay stated that she believes that the cemetery association should use money set aside in the Copeland Cemetery Fund that they have not been using and not ask the taxpayers for funding. It is her understanding that the Copeland Cemetery Fund is intending to give money back to the town after years of not being used, asked John Weatherhogg, cemetery fund trustee, is that correct?

John Weatherhogg answered will the Pleasant View Cemetery Association receive money from the Trust? Yes, the request is in, but the money has not been sent. The fund money is specifically there to maintain the Copeland Family plot in the cemetery and anything left over after that maintenance can be used for general maintenance.

Jenny Talke Munyaiak stated that in theory there is money in the Copeland Cemetery fund to fund the Pleasant View Cemetery.

Additionally, she asked for clarification on the cemetery report, page 42, a payment of \$10,000 into the fund from the Middletown Springs First Response.

Terry Redfield answered that when the Middletown Springs First Response dissolved they disbursed their funds to the volunteer fire department and the Pleasant View Cemetery Association.

No further questions.

12. Shall the voters of the Town of Middletown Springs deem necessary and appropriate **\$32,554** for the support of **Poultney Rescue Squad** determining that the program serves the residents of the town with emergency life support and transport services?

Jenny Talke Munyaiak stated that this request has gone up about \$21,000 over last year. Is anyone here from Poultney Rescue Squad? If not, can the selectboard speak to that?

No representative from Poultney Rescue.

Patty responded that as with any request, this comes into the board as a letter of request and reports for the town report. This year the letter asked for \$41 per person based on the 2020 census. There was no explanation and no visit from Poultney Rescue Squad. Beyond that the board has no other information.

Carl Haynes stated that the request in Poultney was in excess of \$120,000 and he believes it's a spinoff of what's being charged in Fair Haven. Small services just can't last in this economy.

Carl then asked why there was no Sheriff's department article this year?

Peter remarked that he has enjoyed being a member of the selectboard over the past year. He thanked the rest of the board members for the honor of serving the town. He noted that not very many people come to the meetings and it's important to come to meetings and get information directly from the source.

Patty thanked Max Holmes and his dad Mark Holmes, who made it possible for us to successfully navigate a hybrid meeting. They put in a lot of time to source, set up, and monitor the equipment necessary to help us effectively communicate across the different platforms.

Kimberly recessed the meeting until Tuesday at 7am at the town office.
