

Large Dumpster Day

The autumn version of 'Big Dumpster Day' is rapidly approaching, and we look forward to seeing many townsfolk on **Saturday, October 4, 2025**. The event will be held from **7:00am until 12pm** at 577 West Street location.

Middletown Springs residents may discard large unused or unwanted items such as furniture, mattresses, children's toys, and small amounts of construction/demolition debris that do not qualify as normal household trash. **No contractors, please**.

The charge per vehicle OR trailer load is \$10.00; truck and trailer loads are \$10.00 each (or \$20.00). Metal-only loads may be disposed of for free.

Special Notes: Please note that in the interest of staff safety and efficiency, all small items must be in contractor bags or some form of disposable container as much as reasonably possible. This will aid the working staff in the efficiency of the unloading process and create a safer, more streamlined work environment as well.

Non-conforming loads may be turned away at the staff's discretion. Regular household trash and recyclable items, including electronics, **must** be taken to Fort Dumpster. Items containing refrigerant (freezers, refrigerators, air conditioners, dehumidifiers, etc.) are subject to a \$25.00 fee per item and will be accepted at either the West Street location or Fort Dumpster **during this event only.**

Please note that hazardous materials such as paints, oils, propane tanks, other solvents and the like are not accepted. Tires are not accepted at this event.

Metal items may be disposed of at no charge. The work crew would greatly appreciate mixed loads that are separated as much as possible in order to simplify the unloading process.

Please bring exact change or a personal check in the correct amount (payable to the Town of Middletown Springs) and remain in your vehicle unless instructed otherwise.

The Town of Middletown Springs shall not be responsible for any damages that may occur during the loading or unloading process.



Legislative Update from Chris Pritchard

For this update in the off session, I wanted to let you know some of the things I have been involved in throughout the summer.

I have attended many meetings from invitations I have received through my legislative e-mail. I have several more that I have committed to through October and November.

I have touched base with constituents. I have attended 22 meetings, some with local Selectboards, School Board Chairs, Town Clerks and 911 coordinators. I have also met with several folks in the district to help them with concerns they have brought to my attention and to tried to find resolutions for them. Some of these folks I have not been able to help through a legislative pathway but I try to stay in contact with them. I have a list of all of these constituents that I can review in the event that a legislative path will open and create an opportunity that may help them.

There have been several folks that I have been able to help and resolve the problems and concerns they reached out to me for help with.

One in particular I was grateful to be a part of. I had only been in the legislature for a few weeks when I received a call from a constituent who had fallen prey to a scam and was facing a \$60,000 loss. This constituent had reached out to other sources trying to get help with this and was unable to obtain it; that's when she decided to reach out to me. Quite frankly, I had no idea what to do, how to go about it or if I could even help her, but I assured her I would try. I sought advice from several fellow legislators and ended up taking a trip to see Attorney General Charity Clark. It was Friday afternoon and AG Clark had left for the day but I was fortunate enough to catch Christopher Curtis the Assistant Attorney General and Director of the Consumer Assistance program. He immediately engaged with my constituent who I had on the phone and through his hard work over the next several weeks was able to make her and her husband and their small business whole again.

I am currently working on issues in the towns of Wells, Rupert, and Pawlet. One of these concerns was brought to my attention by the Pawlet Town Clerk, Deb Hawkins, regarding a fraudulent property sale scam that has surfaced in our district and across the state. I have been working with Deb on this and have reached out to Representative Sandy Pinsonault from Dorset, who is also a Town Clerk and sits on the Government Operations Committee. We are in the process of setting up a meeting so we can get a framework that Sandy and I can take to legislative counsel to have a bill drafted and submitted so there is a opportunity for this concern to be addressed by the legislature in the second half of the biennium.

I have also been active in my responsibilities with the Rutland County Delegation being active and attending various meetings. I attended a function that Peg TV sponsored in Rutland where Attorney General Charity Clark and Christopher Curtis attended and spoke about the scams that occur in the state and how to best deal with them. I was invited by Representatives Burditt and Bosch to attend a Town Hall meeting in West Rutland with Speaker of the House Jill Krowinski to share concerns with her and visit a housing project in West Rutland.

I joined Senators Collamore, Weeks, and Williams in Randolph to meet with ANR Secretary Julie Moore and had the opportunity to share my concerns with Act 64 of 2015, (the 3 acre impervious rule), that I have been adamantly opposed to as it is presently written. I feel that this law has done great harm to Vermonters, small Vermont businesses and will continue to do so until it is repealed and repaired. Sadly, our committee chose not to do that with still the second half of the biennium left for us to work on and fix. Some small tweaks were made to ease some of the pain but I felt it only delayed the inevitable financial harm it will cause. H481 which became Act 37 was accepted and passed by the House and Senate and signed into law by the Governor. In the near future, this will affect Vermonters in the Connecticut River water shed and those Vermonters that find themselves on that list will experience the same harm that folks in the Lake Champlain watershed have had inflicted on them. I believe Vermonters want clean water and a healthy environment but there must be an equitable balance between achieving that outcome without forcing Vermont families and businesses to live beyond their means. Both Act 67 and Act 37 I feel they have clearly failed to achieve

I received an invitation from From Wells constituent Mary Nichols, who is the Executive Director at the Child First Advocacy Center and will be attending their Open House at the Howe Center in Rutland October 3rd.

I will be attending a health care meeting at the Rutland Hospital on October 13th. On October 17th I will attend an economic development meeting on act 250 and the 3 acre rule at the Hub in Rutland and later that morning, a forestry field trip ending at the Wood Pellet factory in Clarendon.

I will be at the Manchester Library on October 22nd for a meeting hosted by Representative Monique Priestley regarding data privacy and Artificial Intelligence (AI) concerns.

Lastly I wanted to let you know about the resource that is available to you for Act 73 (The Education Reform transformation) a task force is working through the summer on this and working on redistricting maps which will need to be completed by January if this is to continue to move forward. I am providing a link that will take you to the Homepage so that you can see scheduled meetings, view past meetings and there is a link on that page that will allow you to register to offer public input during meetings if you would like. https://aoa.vermont.gov/school-district-redistricting-task-force.
