TAX NEWSLETTER WINTER 2025 - 2026

Property Tax Payment Options. Personal Checks made payable to the Village of Palmyra, escrow checks (please remember to sign the back of the check), money order, or cashier's check or cash (exact amount) are acceptable. The Village collects the taxes and pays the other taxing jurisdictions for the amount collected.

IN FULL OR IN TWO INSTALLMENTS. If you choose to pay your taxes in full, payment must be made to the Village Treasurer by January 31, 2026. If you choose the postponed payment plan, the first half of the taxes must be paid to the Village Treasurer on or before January 31, 2026. The second half, as well as any other tax payment made after January 31st, must be paid to the Jefferson County Treasurer on or before July 31, 2026, 311 S. Center St. Jefferson WI. 53549

BY MAIL Make all checks payable to the Village of Palmyra and enclose the stub of your tax bill. Payment by mail must be sent to P.O. Box 380 and postmarked on or before the due date. Do not post date checks. If you pay in cash, bring the exact amount. Please use separate checks for real estate tax, and dog licenses. Mortgage company checks made out to property owners and the Village of Palmyra must be endorsed by ALL payees prior to payment to the Village. Overpayment refunds will be mailed within 3 weeks of amounts that exceed \$10 only. If you cannot wait for your refund check, please have your mortgage company make out 2 checks, one to the Village for the tax due amount and one to you for the balance in your escrow account. No receipts will be mailed unless you provide a self-addressed stamped envelope.

IN PERSON Payments can be made at the Village Clerk-Treasurer's Office, 100 W. Taft Street. There is a deposit box near the office door on Taft St. for payments after hours. Office hours are: Mon. thru Thurs. 8:00 a.m. to 4:00 p.m. and Friday 8:00 a.m. to 12:00 noon. We will be closed at noon on day Dec. 24, and all-Day Dec. 25th & 26th, 2025, Dec. 31st @ noon and all day Jan 1, 2026. We accept postmarks or drop box payments.

LOTTERY and FIRST DOLLAR CREDIT: The lottery credit is \$163.39 and a first dollar credit of \$54.46 is included in the total tax due on each tax parcel that qualifies and is a primary residence. If you did not get these credits and feel you are entitled to them, contact the Village Treasurer at 262-495-8316. You are eligible for a lottery credit if you lived in your home in the Village of Palmyra as your PRIMARY RESIDENCE as of January 1, 2024. Dog and Cat Reminder. All dogs and cats 5-months or older must be licensed annually by April 1. Forms can be found on the Village Website: https://villageofpalmyra.com/forms-permits/ or in the tax bills. The cost is \$20 for each male/female and \$10 for neutered/spayed pets. A \$20 late fee will be assessed for each animal not licensed by April 1. Please include a current rabies certificate with completed form for each pet and the exact payment amount by cash or check made payable to the Village of Palmyra. Please include a stamped self-addressed envelope so pet registrations and tags can be mailed to you.

- 1. Recycling Fees now on Tax Bill. You will see a separate recycling fee on your tax bill; you paid this before through the general fund tax levy but now it is its own separate charge.
- Election Information. Please watch the Village Website for Election dates. Polls are open from 7 am 8 pm. Voting has moved back to the Village Hall at 100 Taft St. Palmyra. To register to vote or request an absentee ballot, visit www.myvote.wi.gov. 2026 Election dates: 2/17/26, 4/7/26, 8/11/26,11/3/26
- 3. Catch Basins. If you have a catch basin near your home, please keep it clear of leaves, snow, ice and other debris. Your neighbors and the Department of Public Works greatly appreciate your effort.
- **4. Fire Hydrants**. Please keep the safety of your family and neighbors in mind by removing the snow surrounding any fire hydrant that is located on or near your property. The Palmyra Fire Department would like to thank you in advance for your cooperation!
- 5. Winter Parking Restrictions. Parking permits are needed to park on any "Village" side street between November 1, 2025, and April 1, 2026. 2 am 6 am. There is NO overnight parking allowed and could cause citations to be issued.
- 6. Snow Removal. The owner, occupant, or person in charge of every building, lot, or part of a lot within the Village shall remove all snow and ice from said sidewalk within 24 hours from the time the snow ceases to fall. If the snow/ice is not removed the Village may clear the snow/ice from the sidewalk without written notice and return the cost to the property owner. It is unlawful to shovel, blow, or plow snow into ANY street within Village limits. If you use a cluster mailbox or have a cluster mailbox located on or near your property, please take the time to remove the snow and ice around the box and keep the sidewalk leading to the mailbox clear.
- 7. Garbage and Recycling Pickup 2026 Calendar is inserted with your tax bill or you can get a copy at Village Hall and on the Village's website. BULK PICKUP for larger items you need to call John's Disposal 262-473-4700.
- **8. Electronic Waste Disposal Event -** June 13, 2026, from 8 am noon at 430 Jefferson St.
- **9. UTVs/ATVs are allowed on all Village Streets-** Follow DNR Code 64 regulating operation and WI Laws. Operation is not allowed between the hours of 10 pm and 5 am. Check with local Police for details.
- 10. Village Hall Hours. Monday Thursday 8 am 4 pm, Fridays 8 am noon.
