2021 Budget Presentation

The 2021 Proposed Budget for the McGinnis Lake District was presented by Ken Roberts. The Proposed Budget for **Revenues** consisted of a Tax Levy of \$9355.77. and a Carryover from 2020 of \$13,224.23.Total Revenues was \$22580.0 Administration of \$2,230.00 (Lake District Insurance of \$1000.00, Lake Alliance Membership of \$150. Supplies, Postage, Mailings etc.\$1000.00 and PO Box Rental \$80.00), Total Administration was \$2,230.00. Lake Management of \$2021Permitting for Lake Weed Control of \$750.00, Lake Weed Control of (chemical spraying)\$9000.00 Lake Weed Control (Weed Harvesting)\$7000.00. Lake survey \$850.00 Fisheries \$1000.00. Easement for Aerator/Maintenanc\$750.00.With a Contingency Fund of \$1,000. The Total Proposed Budget for Expenditures is \$22,580.00 Approval of the 2020 Proposed Budget will occur later at the Annual Meeting.

\$800.00 . Cason Treatment permit was \$98.00. ACLA MEMBERSHIP WAS \$100.00 Cash Outflows were
\$7,347.71 The current Cash Balance as of September 5,2020 is \$13,982.34. A motion was made by David Presser to accept the Treasurers report as read. Mike Lendzion seconded the motion. The motion passed.
