The Applicant shall pay such costs upon receipt of one or more invoices from the Town, following the execution of the dvelopment review services associated with the application. In the event the Applicant fails to pay such costs, the responsibility shall pass to the property owner, if different, under the same terms. Development review fees that are assigned to the Applicant or property owner, but that are not actually paid, may then be imposed by the Town as a special charge on the affect property.
