RESOLUTION

A RESOLUTION PERMITTING UNDERAGED PERSONS TO REMAIN ON CLASS "B" LICENSEE PREMISES DURING TIMES WHEN NO ALCOHOL BEVERAGES ARE CONSUMED, SOLD OR GIVEN AWAY.

WHEREAS, Wisconsin Statutes Section 125.07(3) provides that underaged persons not accompanied by their parent, guardian or spouse who have not obtained legal drinking age will not enter or be allowed on any premises which a license or permit for the retail sale for alcohol beverages has been issued but this prohibition does not prohibit an underaged person who enters or remains in a room on Class "B" or "Class B" licensee premises on a date specified by the licensee or permittee during times when no alcohol beverages are consumed, sold or given away; and

WHEREAS, it is the intention of the Town Board of the Town of Brussels to adopt an ordinance permitting underaged persons to enter and remain on the Class "B" or "Class B" licensee premises on dates specified by the licensee or permittee during times that no alcohol beverages are consumed, sold or given away.

NOW THEREFORE BE IT RESOLVED. that the Town Board of the Town of Brussels, Door County, Wisconsin, hereby orders and resolves that underaged persons may enter and remain in a room on class "B" or "Class B" licensee premises in the said Town of Brussels on dates specified by the licensee or permittee during times when alcohol beverages are not consumed, sold or given away and only during those times when the licensee, the agent named in the license if the licensee is a corporation or a person who has an operators license is on the premises unless all alcohol beverages are stored in a locked portion of the premises.

BE IT FURTHER RESOLVED that the said licensee or permittee will have to obtain a written authorization from the Door County Sheriff's Department permitting underaged persons to be present on the date specified in the authorization after determination by the Door County Sheriff's Department that the presence of underaged persons on the licensee's premises will not endanger the health, welfare of safety of said underaged persons or that of other members of the community.
