## RESOLUTION

Town of Brussels, Door County, Wisconsin

A RESOLUTION AUTHORIZING THE ADOPTION OF THE TOWN OF BRUSSELS CODE OF ORDINANCES CONSISTING AND INCLUDING AS PART THEREOF, AN INTERIM ZONING ORDINANCE AND THE PUBLICATION, FILING, INSPECTION AND ADOPTION THEREOF.

WHEREAS, an interim zoning ordinance entitled *Town of Brussels Interim Zoning Ordinance* has been prepared and approved by the Town

Board of the Town of Brussels and the County Board of Supervisors of

Door County; and

WHEREAS, such Interim Zoning Ordinance is to be adopted as one of the general ordinances of the Town and constitute a part of a code of ordinances of the Town of Brussels;

NOW, THEREFORE, BE IT RESOLVED: That the Town Board of the Town of Brussels authorizes the enactment of a code of ordinances for the Town of Brussels and that there be included as part of said code of ordinances, the Town of Brussels Interim Zoning Ordinance;

BE IT FURTHER RESOLVED: That the Code of Ordinances of the Town of Brussels, including as part thereof and as a chapter thereof, the Town of Brussels Interim Zoning Ordinance, be presented for adoption and enactment by the Town Board of Brussels at a Town Board meeting to be held on the <a href="#">14+4</a> day of <a href="#">September</a>, 2000;

BE IT FURTHER RESOLVED: That such Code of Ordinances and the Town of Brussels Interim Zoning Ordinance be enacted by an ordinance referring thereto and referencing by chapter number such Town of Brussels Interim Zoning Ordinance, as a part thereof, which zoning ordinance shall be published in separate book form;

BE IT FURTHER RESOLVED: That such Code of Ordinances and the Town of Brussels Interim Zoning Ordinance, as part of such Code, be enacted by an ordinance referring thereto and be published in book or pamphlet form and that copies thereof be permanently placed on file and open to public inspection in the Office of the Town Clerk, after enactment, and for a period of two weeks prior to enactment;

BE IT FURTHER RESOLVED: That the Town Clerk shall cause a copy of the following Notice to be published as a Class One notice in the Door County Advocate within 30 days of the passage of this Resolution:

The Code of Ordinances creates the Town of Brussels Interim Zoning Ordinance as Chapter 2 of the Code of Ordinances.
