The Town Board of the Town of Brussels is authorized to exercise the right to construct a new South B.U.G. Fire/EMS building and an addition onto the North B.U.G. Fire Station at an approximate cost of \$2,800,000, with the share to be paid by the Town of Brussels to be 18.36% of the total cost or \$514,206.

The Town Clerk shall properly post or publish this resolution as required under s.60.80, Wis. Stats., within 30 days of the below-noted adoption date.

Adopted this 19th day of April, 2016.

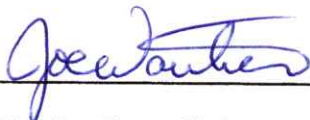

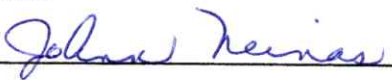
