



VILLAGE OF DENMARK SUMMARY

- Denmark had 79 total incidents in August
- DEO Dzekute and DEO Delebreau handled 32 of the 79 incidents in the village (40.5%)

VILLAGE OF DENMARK PATROL

- DEOs made 14 traffic stops, issued 11 citations, and 7 warnings.
- County officers continue to add extra patrol in the village to assist the DEOs
- One warrant arrest for the month of August. DEO's continue to check for active warrants in the Village.

BROWN COUNTY DRUG TASK FORCE IN DENMARK

- Both DEOs continue to monitor the drug tips to keep up to date on any possible drug activity in the village.
- There have been drug tips from some residents that have come in to the DEOs and they will be following up on them





B.C.S.O. **INVEST-** • There are 0 open cases in the village at this time.

• There was one case during the month of August which was closed out.

IN **DENMARK** • The DEOs continue to work with and communicate with the BCSO Investigators about open cases and current investigations.


OWI ARRESTS IN

- 08-02-17 DEO Delebreau assisted the Highway Dept. with a concrete blow out on the I43 ramp.
- 08-09-17 DEO Delebreau assisted the Middle School Marching Band with traffic control as they marched from the school to Scandinavian Court Assisted Living Facility.
- 08-09-17 DEO Delebreau made a traffic stop. Through his investigation he was able to take a party into custody for an active arrest warrant.
- 08-13-17 DEO Delebreau responded to report of a reckless driver complaint. He was able to locate and stop the vehicle and during the course of the traffic stop, it was established that the driver was operating while intoxicated and was arrested.
- 08-22-17DEO Delebreau and a County Patrol Officer attempted to take a party into custody on an active arrest warrant. No contact was made with the party at that time.
- 08-29-17 DEO Delebreau met with the Crossing Guards about the upcoming school year.
- 08-30-17 DEO Delebreau attended a warrant class at the Sheriff's Office.



WHY OFFICERS DO WHAT THEY DO:

• This is a new addition to our monthly report. It was brought to our attention that there are a lot of things that officers do on the job that the general public might have questions about. Each moth we will try to explain some of the things that officers do during their shift.

• Traffic Stops

- After observing a violation, officers look for a safe place to stop the offender. Officers don't want to make traffic stops on hills, curves or anyplace else where other traffic may present a danger. After stopping the offender, there may be a delay before the officer makes contact with the driver. Notifying dispatch of the traffic stop and doing a record checks may delay the officer a few minutes before making contact with the driver. After making contact with the driver, the officer returns to his squad and may do additional record check and writing a citation or warning. Citations and warnings are done the squads computer and putting in the information takes time. It may take several minutes before the officer makes contact with the driver again to issue the citation or warning and to let the driver be on his way.
- If you have anything questions about other things an officer does please let one of the DEOs know and we will try to address it in a future report.



INFORMATION BULLETIN

- IRS scams are still going around so please be aware of anything you think is a scam. A big thing to remember is that the IRS is going to use the postal service if there is going to be any contact. Another scam is getting a call from a family member indicating they are in jail, usually in another country, asking for bail money. If you receive a call that you feel is a possible scam **don't** give out any information and report the incident by calling **920-391-7450**, there is also on-line reporting at the Sheriff's Office web site.
- Just a reminder to keep all vehicles, homes, and outbuildings locked. We may trust our neighbors, but can we always trust the stranger that finds their way into the village. **DON'T** be a "soft target" for criminal activity.
- It is important to remember to call in any type of suspicious activity. With the recent string of thefts we have had some incidents that have not been called in when they happen. The sooner the activity gets called in the sooner we can get officers in the area and hopefully get this problem to stop. The number to call is 920-391-7450. If it's an emergency always dial 911.
- The voicemail in the DEO office is now set up. We will be checking the voicemail throughout our shift. If you need an officer to come out please continue to use the non-emergency number listed above or below or 911 for an emergency.
- If there are any drug issues that you notice throughout the village and you would like to report them please call the **Brown County Drug**Task Force tip line: 920-437-DRUG(3784). The tips that come in from the village will get sent and viewed by both DEOs. We can then follow up on the tips.

This is what we use to make our plans on how to patrol the village. If there is an emergency that needs law enforcement action please call 911.
