## **Summary**

- ❖ 162 calls for service in the Village of Denmark from 3/1/2023 3/31/2023
- ❖ Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

## In the Community

- PRESCRIPTION DRUG TAKE BACK <u>Prescription Pill Take Back Event April 22, 2023</u>, from 8am-12pm at the Denmark Village Hall. As a reminder, this drop off site is open Monday Friday during normal Village of Denmark municipal hours.
- Coffee with a Cop Tuesday mornings from 8-9am, a Denmark DEO will be present at DeGrand Family Restaurant for Coffee with a Cop, residents can come in ask questions, voice concerns, and get to know the Village Officers!

## Meetings, Associations & Presentations.

Denmark Municipal Court is scheduled for May 3, at 6:30PM. Court is normally scheduled for the first Wednesday of the month at 6:30 PM (subject to change).

#### **Traffic / Ordinance Enforcement**

- Officers use traffic enforcement as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
  - There were 26 traffic <u>contacts</u> initiated and 3 traffic <u>crashes</u> in the Village of Denmark.
    - Of those traffic contacts, 26 traffic citations issued, and 30 traffic warnings issued.
    - 1 OWI arrests / citations.
- Ordinance citations are used to enforce the codes that are specific to Denmark. There were 42 ordinance citation(s) issued.

#### **Administrative**

- Denmark DEO's actively assisting BCSO Investigative with 3 cases
- Significant Calls for Service:
  - ❖ Theft from Business— DEO Rusk took a report of a theft from local Business resulting in a significant loss. Both DEO's assisting BCSO Investigators with follow up.

## Significant Calls Continued-

- \* BCSO Deputies responded to the Village for a Burglary call resulting in property damage.
- ❖ BCSO Deputies responded to the Village for a weapons call.
- Identity Theft / Fraudulent Use of Identifying Info- DEO Pigeon took a report of a significant Fraud involving a local Business. This case is currently an ongoing investigation. DEO Pigeon assisting BCSO investigators.

## Chronic Nuisance Properties (CNP)

- Currently, there are 2 properties deemed a CNP in the Village of Denmark.
- DEO's working with Landlord(s)/tenants

## **❖** Sex Offender Registrants

- Currently there are no active Sex Offender Residency Appeals.
- Currently 0 Sex Offender (pending) Appeal process for Residency within the Village.

#### **Information Bulletin**

#### Park hours

○ Reminder, park hours for the public are from 8:00 a.m. – 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within park after hours.

## Overnight Parking

Reminder: Village Code 289-5(B) states: "No person shall park any vehicle between 2:00 a.m. and 6:00 a.m. from November 1 to April 1 on any village street."

#### Animals at Large

Reminder, Village Code 111-3(A) states "No person, owner, or custodian shall permit an animal to be at large within the Village. Any animal shall be deemed to be at large when it is off the premises owned or leased by its owner or custodian unless crated, penned, or under the control of a person able to control the animal by means of a leash of sufficient strength to control the action of the animal or such other personal attention as will reasonably control the conduct and actions of the animal.

## Keeping of Cats

Reminder, Village Code 111-5(C) states "Number of cats limited. No person shall own, harbor, or possess more than three cats on any residential lot without the prior approval of the Village, except that a litter of kittens, or a portion of a litter, may be kept for not more than eight weeks from birth. An application for prior approval of the Village shall be signed by the applicant and the owner of the residential lot if the landowner is not the applicant. If more than one family resides on a residential lot, then only three cats shall be allowed on the residential lot unless the prior approval is obtained from the Village. For the purpose of this subsection, the term "family" shall be defined as one or more persons."

#### **Crime Prevention**

- ❖ House Check Requests
  - Remember, if you're leaving town for a weekend or taking a vacation or traveling –fill out a house check request form; it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.




- ❖ To file a police report, report suspicious activity/persons, ordinance violations, or you witness a crime, call Brown County Non-Emergency at (920) 391-7450.
